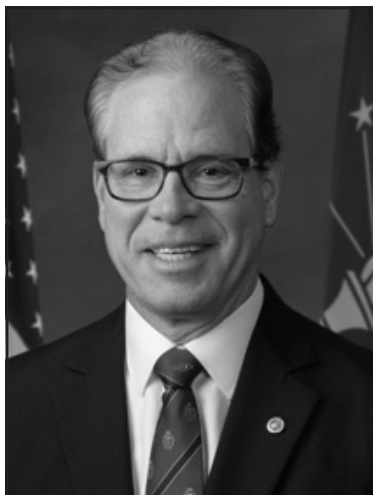

U.S. Senator Mike Braun

Senator from Indiana



Senator Mike Braun was elected in November of 2018 when he defeated one term Senator Joe Donnelly. Prior to that Mike Braun was the State Representative for Indiana House District 63 from 2014 to 2017 when he resigned to run for U.S. Senate. In the primary of 2018 Mike Braun defeated two sitting Congressman to win the right to challenge Joe Donnelly for the Senate Seat.

Before Braun's historic victory in 2018 and his stint as a State Representative He was the founder and CEO of Meyer Distributing, a company he built in his hometown of Jasper that employs hundreds of Americans across the country.

Mike graduated from Jasper High School in 1972, Mike went on to graduate from Wabash College where he earned an economics degree, graduated summa cum laude, and served as President of the Student Body. In 1976, Mike married his high school sweetheart Maureen and entered Harvard Business School, earning an M.B.A. in 1978.

After graduation, Mike took a different path than many of his classmates and moved back to Jasper to start his career. In 1979, he co-founded Crystal Farms, Inc. which later became one of the largest turkey operations in the Midwest. Throughout the years, Mike has always looked for ways to give back to his community and serve his fellow Hoosiers, such as serving as a member of the local School Board and as a State Representative in 2014. As a State Representative, Mike has partnered with conservative leaders like Vice President Mike Pence to deliver results for Hoosiers. The 2016 Indiana General Assembly was ranked as the most conservative legislative body in the country.

Senator Mike Braun has been a strong supporter of the Right to Life and for protection of the unborn since his early days in the Indiana House and has continued that support while serving in the U.S. Senate. This is one of the reasons the selection committee selected Senator Braun as the 2020 Daviess-Martin-Pike County Right to Life Banquet Speaker.

The Adoption Story

My husband and I began the discussion about adoption very early in our marriage. Both of us were youth leaders at New Hope Christian Church in Washington, Indiana, and there was a couple in our church who fostered children and had also adopted. We were inspired by the impact and love we could see this couple was having on the children in their life. We would have loved to have adopted one of their little guys, but the foster care system really wanted a biracial couple. I'm not sure why we didn't pursue adoption any further at that time. Over the next 20 years we had three children and had still just always talked about adopting through the foster care system. I sometimes wonder how many blessings we missed out on because we just talked for so many years.

In 2013 we had a wonderful small Bible Study Group and we were doing the David Platt Bible Study Radical and we highly recommend it. A dear friend asked all of us what is something you've always felt God calling you to do, but you just haven't taken steps to do it. Clint said, adopt through the foster care system. We were encouraged to start taking steps in that direction and were prayed for from that day forward by an awesome group that had no idea how they were going to be used by God in the months ahead. We discussed this with our 3 children and they were fully on board and excited.

We started classes and went every time we could find a class being offered. I believe we were certified foster parents in about 6 months. Our house was approved for 3 children; however, we were thinking of smaller with a sibling group of 2. We didn't get a call right away and we really thought we would. After several months my husband received a call asking if we would consider a sibling group of four with ages 1, 5, 6, and 8. We all agreed including our kids. We called our parents and my husband's sister; knowing we were going to need help and everyone was on board. At this point we totally felt confident God had a plan and was working all things out.

Both sides of our family had planned a trip to Branson for Christmas that year leaving on December 21. The kids moved in on December 14, 2014. Our community came through like crazy. They brought over beds, clothes, and lots of Christmas gifts for the kids. The first few days were crazy; fits like we had never witnessed and smiles that were unforgettable. We packed the 12-passenger van to the brim and took off for Branson to celebrate Christmas.

After only a couple days in Branson, I went into the hospital with appendicitis. I had my appendix removed on Dec. 23rd and had some complications and ended up in the hospital for a little over two weeks. Again, we saw God move. My Mom stayed with me in the hospital, while the rest of the family went home. Clint had to go back to work. Each morning the older kids and Clint had a routine to help the younger kids get ready for school. Clint's mom came every morning to watch Ashton and Tyler and stayed long hours to help after school. Dear friends brought the kids home from school every day. The older kids and Suzanne helped the younger kids with homework and evening routines.

Our community was wonderful and brought meals over every night. I ended up with a huge opening in my stomach and had a wound vac put in and finally came home, but wasn't allowed to get up. My mom became my nurse doing all of the medical stuff that needed done, Clint's family continued to come and help every day. Our friends brought the kids home for the remainder of the semester because the doctor wanted me off for an entire semester. There were a few people that would continue to question us asking if we were going to tell the kids' case worker that we just couldn't do it, after all they would have to understand. To be absolutely honest I don't think anyone in our house ever thought that was an option.

The days were hard, the fits were big (sometimes over an hour long 10 times a day); but watching God working this out was amazing! Our Bible study group, family, close friends, and our community prayed hard for us and filled in so many gaps. One friend even stepped up and taught one of the kids that Dept. Of Child Services said needed to be in school, but he was not ready. This was a huge blessing. The kids began to realize the love they had at our house and in the community and things began to get better.

We were finally able to adopt on Sept. 19, 2016. We still have a few rough patches, but wow do they just fit right into our family. God has worked in each of us and had we not followed his lead we would have missed out on so many blessings! As excited as we are that they are part of our family, I do have to say this was not God's first choice for these kids. His first choice was a loving home with their biological parents. I know their mother loved them and we are so glad she chose to have them as opposed to having an abortion.

Our charge for you is to find those women who made the choice of life and quickly became overwhelmed with no support. For our children's sake I wish someone had come alongside their mother and introduced her to Jesus and helped her make better choices. We pray for her and pray she is able to see God work amazing wonders in her life and feel His love.

HISTORY OF DAVIESS COUNTY RIGHT TO LIFE INC.

The Daviess County Right To Life Organization was founded in November of 1976 when a small group of people met and decided it was time to form an organization in Daviess County to promote life and work to overturn the Roe vs. Wade Decision which legalized abortion in 1973. A group from Evansville was instrumental in helping our organization get started. Some of the individuals from Daviess County helping to form the organization was Bob Johnson Pastor of Plainville Christian Church along with Ben Ray & Eva Bean, Pastor of Bethany Christian Church, along with Bernie & Alma Wichman, Bill & Josephine Wichman, Margaret Wichman and Vic Hopkins. Bob Johnson became the first president of the organization.

Daviess County Right To Life held its first Banquet in November of 1977 with Wayne Smith as the Speaker, and it was held at the Plainville Lions Club Building in Plainville. We have held a banquet each year since that time, and this has become the highlight of the year for the organization as hundreds of pro-life people come together to renew their effort in the fight against abortion in this country. After the first Banquet was held in Plainville the Banquet was then held at Washington High School for two years and then moved to the Ruritan Building in Montgomery for the next 26 of 27 years with the exception of the Gasthof Restaurant in 1997 before moving to the Simon J. Graber Building which will be the third year. Each time it was moved to accommodate the larger crowds that attend the Banquets.

In 1980 Daviess County RTL was put on the Map when our Banquet was held at the Montgomery Ruritan Building as Dr. Jack Willke and Barb Willke spoke to the nearly 500 who attended this event. The Pro-Life Movement was just coming on the National scene, and National CBS sent a film crew from Chicago to cover this event. The State Right To Life President attended along with Dan Quayle who was running against Senator Birch Bayh made a guest appearance. Film clips from this event were seen on National TV on the CBS Morning Show a day later. The reason the film crew came was to find out why the grass roots pro-life movement was growing so fast and to gage the impact it might have on the 1980 elections, and it did not take long to find out. The film crew could not

get over the large crowd that attended in this rural area and was impressed with Southern Indiana Hospitality. Future Banquet Speakers have included major names in the pro-life movement and national figures.

Daviess County Right To Life Organization has been instrumental in helping other Right To Life Groups in our area to form or to give them a helping hand either with donations or with organizational help for their organization. Daviess County Right To Life has been very much involved on the State Level as our local President has not only served as State President but has served on the National Right To Life Board of Directors representing Indiana. Daviess Co. RTL has not only been active in our local area but have been active on the State and Federal level as well. Daviess County Right To Life Organization does not receive funding grants or donations from State or Federal organizations of any kind. The only sources of income for the Organization is from donations from its members and Paper Drives which was started back in 1978 and continues to this day. Daviess Co. RTL opened an office on Main Street in Washington in the early part of 1998, and thru the efforts of then President Donna Gentry opened the Pregnancy Care Center in January of 1999. The Center has now grown where it has its own identity and office staff and serves hundreds of individuals each year. The Pregnancy Care Center and Daviess County Right To Life Organization now share offices in the lower level of the Grace Baptist Church on Troy Road in Washington.

In the years of existence Daviess County Right To Life has only had three Presidents, Bob Johnson from 1976 to 1978, Louis Kavanaugh Jr. from 1978-1995, Donna Gentry from 1995 to 2006 and Louie Kavanaugh Jr. has returned to the office of President in January of 2007 to the present time. Daviess County Right to Life has been very blessed with so many dedicated people who have given so much of their time and effort for the organization. Daviess County RTL has promoted life and worked against abortion thru Radio and Newspaper ads, Booths at Fairs and Montgomery Turkey Trot, put on programs at churches and schools and have lobbied our elected officials to support pro-life legislation. Although we are small in numbers, we have individuals who give it their all for the organization.

Our Organization was hit hard in January of 2011 while honoring Donna Gentry with a Memorial Bench at the site of the First Pregnancy Care Center She suddenly took ill and died a few days later. It was a shock to the organization and to her family and friends who knew her well. She

was the founder of the Pregnancy Care Center and served as President of the Daviess Co. RTL for 1995-2006 and worked tirelessly for the organization. Many projects she undertook was a real shot in the arm not only to the organization but to the pro-life movement. She ran for State Representative on two occasions and nearly upset a long term incumbent in her first try for public office.

Although we have made history in the past, we truly hope the history we make in the future will be that all lives of the unborn are protected from conception to natural death. May God Bless our all of us in our work and Bless our Country!

Bethany Christian Church, Near Montgomery, Site Where Daviess Co. RTL Held Meeting for Many Years



The picture above of the old Bethany Christian Church west of Montgomery on Hwy 50 was taken just two days before the church was taken down. This was the site where Daviess County Right To Life held its meetings for many years. After the first meeting was held at the YMCA in Washington the meetings were moved to Bethany Church in 1976. Ben Bean who was the Pastor there for over 40 years invited the Right To Life to hold their meetings at the church and Ben Bean became the Vice President and held that position for many years. Ben & Eva Bean were very hospitable to the Right to Life members, and many lasting friendships were made because of Ben's invitation to the Right To Life.

When Donna Gentry took over as President, and the Pregnancy Care Center was started in January of 1999, the meetings were then moved to the Main Street location of the PCC on Main Street in Washington. After the building sold, the Right To Life & the PCC were moved to 608 West Walnut Street in September of 2004. In November of 2008 the Right To Life and the PCC moved to the present location on 705 Troy Road in the lower level of the Grace Baptist Church. They are very pleased with the location and the facilities.

It was sad to see the church taken down, but the membership of the church had grown so much they built a new church on highway 57 south of Washington. The old church was taken down on Monday August 11, and it took several days for the clean up. The old site of Bethany Christian Church will always have a soft spot in our hearts, and we will remember Ben & Eva Bean and the many hours we worked together on the many functions for Daviess RTL and the Support they gave us. We will always remember those dedicated members who worked so hard to start Daviess County Right To Life, especially the Wichman Family who are too numerous to name here. We will always remember those early days and thank those who gave so much in the fight against Abortion. God Bless Them!

Paper Drives Continue for Right to Life Organization

Mike Wichman who is now in charge of the Right To Life Paper Drives took over after his Dad Bernie Wichman got sick in 2002 and passed away. Bernie Wichman took care of the Paper Drives from the beginning back in 1978 until his health failed, and Mike, his son, took up the torch. Mike has always helped at the drives and along with his brothers Chuck and Steve Wichman were always dependable help for the drives. In fact, the the Wichman Family has always been well represented at the Paper Drives. Beginning with Bernie and his brothers Bill and Bob and Bernie's children and other members of the Wichman Family, we could not have done it without them. Bernie’s wife Alma always made the sandwiches and got the soft drinks for the crew. When Alma got sick and was unable to do it anymore, their daughter Mary Jo “Wichman” Sellers took over and does it to this day. Mary Jo was also the Treasurer for the Daviess Co. Right To Life for many years and has continued the tradition of the Wichman family helping out at these paper drives. Many of the Wichman Grandchildren have helped at one time or another and continue to do so to this day.

The Paper Drives started back in 1978 at the parking lot next to Washington Catholic School, then moved to old 3-D Plaza, then to the old Big Blue Parking lot and then to Old K-Mart Parking lot, to the Fastenal lot and now back to the Tractor Supply Parking Lot (Old K-Mart Lot.) Over the years the Paper Drives would fill a full semi in one day, but now because of the cut back in newsprint it may take two drives or more to fill a semi-trailer. In the last several years the Right To Life has started recycling aluminum cans, and this has proved to be very beneficial to the group. At one time the Paper Drives also took magazines, but we do not have an outlet to sell them and that was discontinued years ago.

The Paper Drives are held the first Sat. of the even months of the year with the main location at the Tractor Supply Parking lot in Washington. We have pickup points at Plainville, Odon, Elnora, and Montgomery. Over the years it is estimated we have saved a thousand or more tons of paper from going to the landfill and in the process helped the local RTL Organization to promote life. At one point the Paper Drives were the main source of income for the organization but now our donations have increased and have helped the organization to do even more in the battle against abortion. We thank everyone for their support of these drives and hope you will continue to recycle.

In Memory of Donna Gentry

November 16, 1941 - February 2, 2011

Placing the Bench/Monument at the site where the Pregnancy Care Center was founded in January of 1999 was done by Daviess County Right To Life Organization to highlight the significance of that endeavor. This bench would also honor Donna Gentry who was the founder of the Pregnancy Care Center and honor the many lives she has been able to touch, the many people she has helped and for her many accomplishments in the pro-life movement. The work of the Pregnancy Care Center would not have been possible without the dedication of Donna Gentry to see it through.

Ever so often you come across an individual who has made such a huge impact on their community, and this has been evident in Donna Gentry's passing. The impact by Gentry was evident by the many people who paid their respects and to the large crowd who attended her Funeral. Donna's Granddaughter Brianne Rainey said it best as she ended her remarks at the Funeral. **"We remember her as a great woman, but she wasn't, she was a simple woman that did great things through Jesus."**

Donna's spirit will live on in the pro-life work she has started.

"What is happening to America because of abortion?"

Our world changes every day. Different topics shift in and out of the spotlight due to the influence of popular culture, social media, and current trends. In the course of one week, the news topic may vary from a celebrity wedding, to a political scandal, to Apple's latest technology. We are easily distracted by what society says that we should pay attention to. Part of this distraction is inherent to the information age that we live in, as people connect in ways that were not possible just a short decade ago.

Our short attention span has caused us to move on quickly from what should be important value-centered topics such as abortion. We move on because it is inconvenient to pause and have meaningful discussions in such a fast-paced world. Essentially, America's values are compromised by a desire for social acceptance. Society wants to put all of your beliefs, actions, and policies into a labeled box. You are then judged on whether or not you conform to modern standards.

When the laws of the land changes to accept compromised moral values, America becomes slowly numb. Our nation adjusts to accept a "new normal", regardless of whether the behavior is right or wrong. Since *Rowe V. Wade* in 1973, the legality of abortion has desensitized us to its acceptance as common practice. My parent's generation, and mine, have both grown up being told that the right to terminate a pregnancy is acceptable.

Abortion should not be an item for debate. The same way we can have absolute agreement on the illegality and moral wrongdoing of the murder of a 22-year-old robbery victim. We should have the same mutual resentment for the killing of the unborn. Just this year, 2,411 babies were buried in South Bend after being found in storage at the home of a recently-deceased abortion doctor. This shocking discovery was covered in the media for a few weeks, but truly failed to capture the national attention and outrage that it deserved. Our cultural immunity has allowed this travesty to quietly slip away as "old news". Since becoming legal, State Legislatures and Right to Life groups now look for smaller victories. We try to split the abortion issue into discussions and legislation about late-term, partial-birth, consent laws, and funding restrictions. We are forced to search for avenues to win small battles, rather than the overall war. An example of this is Indiana's recent passage of SB299 that mandates counseling related to aborted fetuses. Though these wins are important we are fighting what should be a value-centered battle with technicalities.

Values are always the most important principles to be considered when making life choices. Most of the news today centers on Democrats vs. Republicans and conservatives vs. liberals. As I have grown up, my father has always said that your moral values should guide your political decisions more than any party affiliation. I consider myself a Christian first and foremost. Based on my faith, I find myself more of a conservative than a liberal. Finally, I use these values to choose to affiliate with the Republican Party. One of the most important values that I base this decision on is my stance on the right to life.

Winner of 2020 Marvin Arvin Memorial Scholarship

“What is happening to America because of abortion?”

Abortion was illegal prior to Roe vs. Wade decided by the Supreme Court of the United States on January 22, 1973. This decision divided the United States into pro-life and pro-choice. Some states allow women to have abortions after they have given birth. Many babies are too large and the doctors are dismembering them to remove them from their mother’s wombs. It is sad that America is allowing this to happen to these unborn children.

Many issues are dividing our country and abortion is one of the hot topics. Republicans want to stop abortion and democrats believe women have the right to choose. Women are having full term abortions. Baby parts are being harvested and sold for stem cell research. This is big money for the Planned Parenthood organization. They charge these women hundreds of dollars and then sell the body parts for thousands of dollars more.

As of June 2019, nine states and the District of Columbia allow abortion up to birth. Those states are Alaska, Colorado, Illinois, New Hampshire, New Jersey, New Mexico, New York, Oregon, Vermont, and Washington DC. Some states are allowing infanticide also known as post birth abortions if a woman states that it is too stressful and do not want the baby. In some states, when abortions fail and the baby is alive after birth, a doctor can kill them.

Some women are given two abortion pills. First Mifepriston, then two days later Misoprostol to stop the woman’s womb from absorbing progesterone. The baby needs the progesterone to survive. Another method of abortion is medicines: Methotrexate & Misoprostol (MTX) which is given orally or by injection. While we attended a Pro-Life Rally in Washington DC outside of a Planned Parenthood clinic, we listened to one mother describe the churning in her belly as the medicine killed her baby. The medicine causes contractions for several hours and the mother aborts the baby. Horrific abortions happen when the Doctor dismembers babies while they are still in the womb. The pieces of arms, legs, and head are removed in pieces. The Doctors do this because the babies are too big to abort short of actual childbirth and they feel it would be hard on the woman. Many of these women have mental health and medical issues after the abortion procedures.

Pro-Life. Let us move on to Euthanasia. In the Oxford Dictionary online, Euthanasia is defined as the painless killing of a patient suffering from an incurable and painful disease or in an irreversible coma. The practice is illegal in most countries. Euthanasia is legal in Belgium, Canada, Columbia, Luxembourg, The Netherlands, Switzerland, and in six US States; California, Colorado, Montana, Oregon, Vermont and Washington State. There are people who want this mercy killing or assisted suicide to be legal. We do not get to choose when we are born and we should not get to choose when we die.

We should all be pro-life. The best way to keep from getting pregnant is abstaining from sex until Marriage. We should not support mercy killing of our elderly. Our life was given to us by God the Father and we should appreciate every day that we have here with our friends and family until he calls us home.
