

Right To Life Banquet Set for Thursday October 3



The Right To Life Banquet will be held on Thursday October 3 at the Simon J. Graber Building. Dr. Grant Clark a former abortionist, who saw the error of his ways and is now trying to correct those mistakes, will be the Main Speaker.

While practicing as a family doctor in Eureka, CA (1970), he began taking courses on abortion given by Planned Parenthood in nearby San Francisco. He was influenced by Planned Parenthood’s propaganda, which was: “If there were no unwanted children, there would be no abuse.” Just a few years after finishing medical school, he began committing abortions. He only recently broke his silence about that dark chapter in his long medical career, because, he explained, “What the Lord has put me through ... was gradual. ... It takes courage to admit you were a murderer.”

Dr. Clark stopped committing abortions in 1972—a year before two tragic U.S. Supreme Court rulings decriminalized abortion nationwide. After he renounced abortion, he responded to an advertisement for a position as a family doctor in the small town of Benton in a quiet corner of rural Pennsylvania—far removed from the traumas he had experienced as a West Coast abortionist. He had planned to stay in the area for only a year, but ended up staying for more than two decades and also helped pioneer a new Christian faith community there. After retiring from private practice, he worked in the prison medical system a number of years. We feel Dr. Clark has a powerful story to tell about abortion and his conversion to the pro-life movement. Please keep the date open in October for this powerful testimonial.

Abortion has been a huge issue in the political scene since the Supreme Court ruled it legal in *Roe v. Wade* in 1973. Political careers have been constructed, and also tarnished because of a politician's position on the issue. Many people, even if they agree with a candidate on every other issue in America, will not vote for someone solely based on the answer to one question: Are you pro-life, or pro-choice? Due to corruption that has become the norm for any sort of politician in the United States; some politicians even use this issue to raise support from a certain demographic hoping that their official answer to this question will sway the people toward voting for them.

Outside of politics, the past 40 years since *Roe v. Wade* have shown staggering changes in the churches as well. More and more Christians are publicizing their take on the issue, and more and more division is rising between denominations for their opposing stances. Regrettably, many churches are saying that they accept abortion as a valid form of birth control. Others uphold that the termination of a fetus's life is an abomination before God. This issue is tearing apart communities, churches, and even families.

As both government and churches are supporting abortion, more and more young girls are becoming pregnant before they graduate from high school. Premarital sex has become the norm in high school student bodies, and increasingly becoming a social necessity. keep it, which most cannot economically afford, or they take the convenient, quick option of abortion.

The pro-choice option is what is most appealing to Americans. We are America. We pride ourselves in options, and in allowing people to choose different options to live harmoniously together. We also pride ourselves in convenience. We always look for the easiest option, the shortest route from where we are to where we want to be. And so often people look at the issue of abortion and choose the one that leaves a choice, the one that seems convenient. Unfortunately, that happens to have led American people to kill nearly 56 million unborn human beings since *Roe v. Wade*.

For churches, our primary job is to spread the Gospel of Jesus Christ to all people. Supporting something that kills people before they even draw their first breath is not the right way to do so. The Gospel we preach is not a gospel of convenience. See, often churches say that abortion is "okay" in order to accept those who perform or have abortions. The way to accept a sinner is not to accept the sin, but to love the sinner in spite of their sin.

For the government, its primary job is to ensure everyone's rights. If America claims that "all people are endowed by their Creator with certain unalienable rights, and that among these are life, liberty, and the pursuit of happiness," then it cannot continue to uphold abortion. When one person's life is denied because of another's liberty, then happiness is not being pursued, but rather suppressed. Where there is suppression, there is oppression; and where there is oppression, the government is failing.

Adoption: Giving Life ... Not Giving Up

Megan made Bill and Lois Martin parents. She made them grandparents. She made them grateful for Kurt and Sheri “Kavanaugh” Behme. Kurt and Sheri, you see, are Megan’s biological parents. More than 20 years ago, they were young adults struggling to decide how best to handle Sheri’s unexpected pregnancy. She was still in high school; Kurt was barely out. “I always just knew I wasn’t ready to be a full-time mom,” Sheri said recently, in the same Catholic Charities offices where she decided to put her baby up for adoption. Kurt, while acknowledging he was the father, had no formal say in the decision. “I definitely supported it,” he said. “We weren’t married, but we knew that we were going to be together forever.”

Theirs is one of hundreds of stories—more than 1,000 in all—that Catholic Charities has helped write over the past 76 years. “We are older than the Diocese of Evansville,” said Director Sharon Burns, “and we are honored to have been part of 1,054 adoption placements through 2012.”

Burns is reaching out to families across the diocese whose lives were changed through Catholic Charities’ adoption program to be part of an “Adoption Family Reunion” on Saturday, Aug. 3, at Evansville’s Bosse Field. The Frontier League Evansville Otters baseball team hosts the Florence (Ky.) Freedom in a doubleheader, and the reunion will include tickets to the game and a “Ballpark Buffet” before the first game, which starts at 4:35 p.m.

“Adoption involves multiple decisions to give life,” Burns said. “We want this reunion to serve as recognition for the many hundreds of those decisions we have been blessed to be a part of at Catholic Charities.”

Megan went to the Martins just a few weeks after Sheri delivered her first daughter—on her due date in a quick-and-uncomplicated birth. “God had a hand in it,”

Sheri said. “I had a little bit of a backache, but basically had no labor at all. I think if the labor and delivery had been more involved, the adoption would have been much tougher. As it was, she was whisked away as soon as she was born.”

Burns recalled that, back then, babies routinely went to foster homes for a minimum of 30 days before final adoption. Before Megan left the hospital for her temporary home, however, Kurt made his way to the nursery for a quick visit with his daughter. “She grabbed my finger with her toes, and I’ll never forget how surprised I was by such a strong grip. Then, she grabbed it with her fingers. I knew ... I had to get out of there,” he said, barely holding back tears. “I kissed her hand and left.”

Fast forward to March 10, 2007 ... the next time Kurt got to kiss his first daughter’s hand. Lives happened—literally—in the interim. Megan Martin made it through school, not without some grade-school teasing about being adopted. “I remember we all talked about it at school,” she said, “and those who made fun of me actually apologized. It never came up again after that.”

Megan got a younger brother, also adopted by the Martins. Matthew is 21 now. She’s 27, married to Andy Wathen, and a mom herself—to Kylan (7), Katelyn (5), Kinley (2) and Khloe (10 months).

Kurt and Sheri, as they knew they would be before Megan was born, are married and have two more children: Alex (13) and Anne (9). And they all have each other. Talk about one big, happy family....

Catholic Charities facilitated Megan’s request for the names and addresses of her birth parents after she turned 21. “I wrote the letter when I was 18,” she said, “and learned I’d have to wait three more years.” She’d been waiting quite some time already, her mind made up.

“As I grew older,” Megan said, “I just didn’t feel complete. I didn’t know where I came from ... just where I was supposed to grow.” Lois and Bill supported the decision from the get-go. “Mom always told me I’d grown in her heart, just not in her belly,” Megan said.

When the time came and she’d written the letters, the response from Catholic Charities was as unsettling in some ways as it was exciting in others. “I really wanted to meet them,” Megan said of Kurt and Sheri, “and it turned out they only lived 10.1 miles away. I looked their address up on Google Maps.

“But there was no way I wanted to break up the four of us,” she said of the Martin family—her adoptive parents and brother. “I asked all of them how they felt about me making contact. If any of them had been reluctant, I never would have done it.”

They weren’t, so she did—and that first meeting with “where she came from” occurred right away. Kurt remembers parking, getting out, and doing something he’d dreamed of for more than 20 years.

“I’ll never forget Megan telling me about it,” Lois said. “She said, ‘When he came up, he said ... the last time I saw you I kissed your hand, and I’m gonna do it again...’” He did, but remained mostly speechless.

“After he kissed my hand, he said ‘I don’t know what to do,’” Megan remembered. “I said, ‘Well, you could let her out of the car!’” Kurt had left Sheri in their vehicle with a huge floral arrangement for their first-born. “I never would have gotten out of there without his help,” she said with a laugh.

Today, two families that found each other through decisions to give life have bonded into one amazing group that includes biological and adoptive parents; biological and adoptive grandparents; multiple generations of brothers and sisters; even an aunt and uncle (Anne and Alex) who enjoy the same video games and TV shows as their nieces and nephews (sister Megan’s children).

“I always felt like one day this would happen,” Lois Martin said of the meeting that led to creation of an amazing extended family. “Deep down, I always wanted to thank (Kurt and Sheri) for giving us these happy years ... and grandkids.”

“So many people in this world think of adoption as the decision to give something up,” Burns said. “Megan and her families are proof that adoption involves giving ... but not giving up.

“I hope any adoptive family reading this will come to Bosse Field Aug. 3 for the Adoption Family Reunion,” she added. “We celebrate your lives and your families, and we invite you to come and celebrate with us.”

Abortion, Planned Parenthood and Dr. Kermit Gosnell

The recent conviction of the abortion Doctor may have taken another abortionist off the street, but it will not stop the killing. Some Jurors in this trial and members of the media said they had pro-choice attitudes going into this trial but after listening to the testimony they changed their minds because of what they heard and what they saw. The sad fact is this is not a rare case; late term abortions are happening more all the time, and doctors who perform these procedures are cold hearted. Democrats Turn Off Hispanics With Defense of Late-Term Abortions

Texas Democrats have lined up behind pro-abortion heroine Wendy Davis in opposition to a bill that bans late-term abortions after 20 weeks of pregnancy. That might be a good idea to solidify the left-wing base of the Democratic Party, but it is turning off a key constituency—Hispanics.

As Politico notes, polls repeatedly show Hispanics are pro-life, and the statewide, and national attention on opposition to the abortion ban can't be doing Democrats any favors with them. As President George W. Bush showed, a pro-life candidate who can directly appeal to Hispanic voters can get good results—with his election efforts winning the support of 40 percent of Hispanics.

From the story:

In their candid moments, Democrats acknowledge that abortion isn't the issue they would have picked to lead the pitch for Latino votes. The fight was forced upon them, they say, when Gov. Rick Perry added the anti-abortion bill to last month's special session and revived it in a second special session that started July 1.

"Is this the issue we would have picked to turn Texas blue? No," Terri Burke, executive director of the American

Civil Liberties Union of Texas, said with a laugh. "It was kind of thrust at us. We didn't pick it."

On the surface, at least, the polls don't look promising for a party that's basking in the national spotlight because of a fight over abortion rights. The Pew Forum on Religion and Public found that 53 percent of Hispanic Catholics say abortion should be illegal in all or most cases. That's a lower percentage than white evangelical Protestants and Mormons, but it's higher than all other religious voting groups, including white Catholics, white mainline Protestants, black Protestants, and Jews.

And Steve Munisteri, the chairman of the Texas Republican Party, cited a poll by the Wilson Perkins Allen research firm that found a 2-1 "pro-life" margin among the state's Hispanic voters. The poll, conducted for the state GOP, showed that 62 percent of Texas Hispanics who voted in the 2012 election described themselves as pro-life while just 32 percent called themselves pro-choice, according to Chris Perkins, the pollster who worked on the survey. Some Democratic strategists say the key to winning over Latinos is to avoid focusing too much on any one issue—especially abortion.

Gov. Perry Signs HB 2, Congratulations to Texas Right to Life for a Job Incredibly Well Done

To state the obvious, it took a titanic effort and nerves of steel to pass a bill to save pain-capable unborn children from abortion and rein in the abortion industry in Texas. Pro-life Texas Governor Rick Perry was surrounded by pro-lifers after signing HB 2. Pro-abortion state Sen. Wendy Davis' filibuster, aided and abetted by an unruly mob of screaming pro-abortion partisans, ran the clock out in the first special session. It seems strange to believe now, but many abortion advocates thought they had prevailed. They did not count on Gov. Perry who quickly announced that he was calling a second special session and would place pro-life items at the top.

Even though early on Davis admitted she could not successfully filibuster HB 2 a second time, that did not mean pro-abortionists were going to quietly accept the inevitable. They were every bit as boisterous, over a longer period of time, escalating their rhetoric and putting pro-lifers in fear of their safety. If the first go round was ugly, the second pass was ugly and ominous and threatening. But the goal, of course, was less to defeat HB 2 in the state House and Senate than it was to capture the hearts (and sympathies) of the assembled media. The fundamental disconnect—pro-abortionists behaving like the extremists they are at the same time they were denouncing the allegedly “extremism” of HB 2—simply was ignored. Indeed the latter was used by media accounts to justify the former. Put another way, the media narrative was that the worse pro-abortionists behaved, the worse HB 2 must be.



Texas House Tentatively Passes Bill to Ban Late-Term Abortions After 20 Weeks

After a full day of debate and pro-life votes to defeat almost two dozen pro-abortion amendments to weaken the bill, Texas legislators successfully approved on second reading a bill that will ban abortions after 20 weeks of pregnancy.

Lawmakers voted 98-49 for the bill on second reading and a third reading vote is forthcoming, likely tomorrow, but the same margin is expected. The vote today for conditional approval is four more votes for the measure than the last time the House approved the bill before Wendy Davis' infamous filibuster.

Five pro-life Democrats voted for HB 2 including Guillen, Herrero, Martinez, Munoz, and Pickett while one Republican voted against it: Sarah Davis. The bill would

ban abortions after 20 weeks and hold abortion clinics accountable by making them meet basic health and safety standards that have closed facilities in other states that are unable to comply. The bill also requires all abortion clinics to meet the same health and safety regulations as an ambulatory surgical center, requires a doctor providing abortions to secure admitting privileges at a nearby hospital, and lastly, requires a doctor to personally administer the abortion-inducing drugs to the patient.

The last attempt to pass the bill was halted in the State Senate with a pro-abortion filibuster but State Sen. Wendy Davis says she will not filibuster the bill a second time. Today, she told CNN she thinks the bill will ultimately pass and be signed into law by pro-life Gov. Rick Perry.

“It will be very difficult because unfortunately the voices that have been here crying out against this bill are not going to be heard,” Davis told CNN in a brief interview. “But I don’t think it’s the end. It’s the beginning of a battle line.” “That’s probably the case,” Davis said about not being able to filibuster the bill a second time.

Today saw a death threat issued to the Texas Lt. Governor and abortion activists screaming “F- the Church.” Texas Governor Rick Perry issued a call for a special session of the Texas legislature to pass the bill that a pro-abortion mob prevented the legislature from passing last week. “I am calling the Legislature back into session because too much important work remains undone for the people of Texas. Through their duly elected representatives, the citizens of our state have made crystal clear their priorities for our great state,” Perry said. “Texans value life and want to protect women and the unborn. Texans want a transportation system that keeps them moving. Texans want a court system that is fair and just. We will not allow the breakdown of decorum and decency to prevent us from doing what the people of this state hired us to do.”

A recent national poll by The Polling Company found that, after being informed that there is scientific evidence that unborn children are capable of feeling pain at least by 20 weeks, 64% would support a law banning abortion after 20 weeks, unless the mother’s life was in danger. Only 30% said they would oppose such a law. Polling from Texas also shows support for the legislation. The bill relies on the science of fetal pain to establish a Constitutional reason for Congress to ban abortions late in pregnancy. The science behind the concept of fetal pain is fully established and Dr. Steven Zielinski, an internal medicine physician from Oregon, is one of the leading researchers into it.

Major Newspapers Reject Pro-Life Ad, Image of Baby “Too Controversial”

Washington, DC (LiveActionNews) - A national pro-life organization is outraged after three major American newspapers rejected a pro-life ad as “too controversial.” *The Chicago Tribune*, *USA Today*, and the *LA Times* refused to run an advertisement created by Heroic Media. The ad features a hand holding a 20- to 24-week-old baby with the quote, “This child has no voice, which is why it depends on yours. Speak Up.”



Heroic Media Executive Director Joe Young said he was shocked and angered that the media outlets were willing to talk about the issue but were unwilling to show the reality of life at 20 weeks.

“I am disturbed that these papers would run article after article promoting the notion that abortion is a victimless act without consequences,” Young said. “The fact remains, children who are unique individuals—never again to be duplicated—are being killed in the most violent way imag-

inable and they feel the excruciating pain of that death.” The newspapers took issue with the image of the baby.

“It seems as though it is okay to talk about the issue in general, but when you actually put a face to the discussion, then it becomes controversial,” Young said. Last week after the House passed the Pain-Capable Unborn Child Protection Act, Heroic Media put out a statement requesting that the pro-life community contact their senators and encourage them to consider and support the Act.

“Americans deserve to know the truth about the children sentenced to die for no fault of their own and that we have a chance to spare some of them through this legislation,” Young said. The Pain-Capable Unborn Child Protection Act prevents an abortionist from performing an abortion at or after 20 weeks, based on empirical scientific medical evidence that proves that unborn babies can feel pain. Science shows that at eight weeks after fertilization, the unborn child reacts to touch, and at 20 weeks, the unborn baby responds to what would be felt as pain.

The image shows a 20- to 24-week-old baby in a person’s hands. Heroic Media’s goal was to show what life looks like at 20 weeks. The non-profit organization has resubmitted the ad with a different image, now one of a 20-week-old baby in utero. The *Chicago Tribune* has now agreed to run the ad with the second image as long as Heroic Media indicates that it is an advertisement. “Our hope is that the American public begins to advance this debate with both the mother and child in mind,” Young said. Heroic Media is a non-profit whose mission is to educate the public in general and reach women facing unplanned pregnancies with life-affirming alternatives through the use of mass media, such as television commercials, internet outreach, and billboards.


MSNBC Host Wears Tampon Earrings to Protest Texas Late-Term Abortion Ban

MSNBC host Melissa Harris Perry wore tampon earrings during a weekend broadcast, telling viewers they were made especially for her to wear to demonstrate her opposition to the ban on late-term abortions in Texas that Governor Rick Perry signed this week.

The liberal anchor said she wore them in part because she is upset Texas police officials had to confiscate tampons at the Texas legislature that abortion activists planned to throw at legislators following the vote for the ban on abortions after 20 weeks of pregnancy. MSNBC is considered a far out liberal network in which they do not present a fair and balance reporting of the news. It is more of a liberal talk show with an anti-Christian slant.
