Election Year 2018 - Who Is Running?

The 2018 election is looming just around the corner, and in Indiana one major race will be for U.S. Senate where the present senator, Joe Donnelly, will seek re-election after a full term in office. When Donnelly was elected he portrayed himself as pro-life, but he has not gone far from his pro-abortion democratic party. The pro-life movement has not been happy with him during those six years. This does not mean he has been a strong pro-abortion supporter either.

Several Republican candidates are lining up to run against him, including Congressman Luke Messer, Congressman Todd Rokita and State Representative Mike Braun. Others are indicating they may run as well. Messer and Rokita are going at each other and may hurt both of their chances. Mike Braun has also entered the race and he, along with Messer and Rokita, all have strong pro-life credentials and would be a much more dependable pro-life vote than Senator Donnelly. Even though President Trump won Indiana by 20% over Clinton, it is expected it will be tough to unseat Donnelly; and it appears it will be a dog fight here in Indiana. There will be some low profile races for the state house along with state senate and state representative races, but the U.S. Senate race will be the biggest of them all.

Federal Judge Sides with IU in Blocking Key Provisions of Fetal Trafficking Law

Indiana University argued new law “builds a wall around Indiana and prohibits tissue from an aborted fetus from entering or exiting the state.”

INDIANAPOLIS - U.S. District Court Judge Jane Magnus-Stinson mainly sided with Indiana University last week in striking down key fetal trafficking provisions of Indiana’s Dignity for the Unborn Act. The ruling means Indiana is blocked from enforcing much of the law aimed at prohibiting the trafficking of parts from aborted babies in Indiana.

“We are gravely disappointed with this ruling,” states Indiana Right to Life President and CEO Mike Fichter. “The purpose of the law is to prevent the trafficking of aborted baby parts in our state. Most of the safeguards in the law are now gutted due to Indiana University’s penchant for using the parts of aborted babies for experimental purposes.” Indiana University sued to block the law due to its provision that prohibits the “acquisition, receipt, sale and transfer” of aborted fetal tissue. In its pleadings, IU acknowledged it obtains tissue from organs such as brains, livers and kidneys for experiments, but argued the law’s definition of fetal tissue is too “vague” when defining it as, “tissue, organs, or any part of an aborted fetus.” IU also argued that the definition of what it means to “transfer” aborted tissue is too “vague.”

Indiana University’s objections were more straightforward when it declared the statute, “builds a wall around Indiana and prohibits tissue from an aborted fetus from entering or exiting the state.”

“The language and intent of the law is clear,” says Fichter. “Yet due to courtroom wrangling over what a word like ‘transfer’ means, Indiana’s protections against body parts trafficking is now compromised.”

While undercutting much of the law’s effectiveness, Magnus-Stinson’s ruling does let stand provisions including the prohibition of selling aborted tissue or organs and the prohibition on altering the timing or type of abortion for the purpose of obtaining parts from aborted babies.

In a key setback for Indiana University, Magnus-Stinson rejected IU’s claim that the state law was unconstitutional because it allegedly violates IU’s right to academic freedom, noting the First Amendment does not prevent states “from enacting statutes prohibiting conduct in which the University would like to engage, and then teach about.”

Tim Tebow on Facing Abortion: Doctors Called Me a “Tumor” Not a “Baby”

As Tim’s mother prepares to speak at the 45th annual March for Life later this month, Tim Tebow is giving a hint of what’s to come: he himself was almost a victim of abortion. In an interview published earlier this month, the former NFL player and current minor league baseball star revealed the story of how doctors encouraged his mother to abort him. He spoke with Pastor Louie Giglio at 2018 Passion, an annual college student conference.

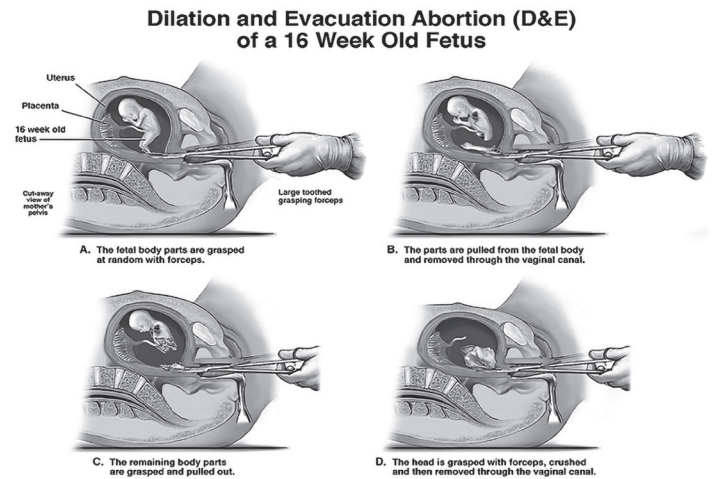
Tebow delved into his story after the pastor asked him what “made you into the person you are?” “I was born in the Philippines to missionary parents and I have a special birth story,” Tebow began telling how abortion almost became his reality. “The doctors said that I wasn’t even a baby; they said I was a tumor.” That was something his siblings never let him forget – he jokingly added that they nicknamed him “Timmy the Tumor” after he was born. Because of his mother’s faith, he said, he was alive today.

“I was born in the Philippines to missionary parents and I have a special birth story.”

“There was a lot of craziness with my entire – with my mom’s pregnancy with me,” he said. “She decided to trust God and not what the doctors were saying.” His life, he said, was a miracle. “And then I was born and it was a miracle — the placenta wasn’t attached the entire pregnancy, but I was malnourished, but I made up for it pretty quickly.” He concluded by thanking his parents for serving as his role models and influencers.

Dismemberment Abortions?

Is it really true that unborn babies have their arms and legs ripped off in a grisly abortion procedure? Yes it is, and one leading pro-life group is calling on Congress to ban them.

Dear Member of Congress: The National Right to Life Committee, the federation of state right-to-life organizations, urges you to co-sponsor the *Dismemberment Abortion Ban Act* (H.R. 1192).

This vital pro-life legislation, introduced by Rep. Chris Smith, would prohibit the performance of dismemberment abortion. H.R. 1192 is based on a model state bill proposed by National Right to Life, which has been enacted in Alabama, Arkansas, Kansas, Louisiana, Mississippi, Oklahoma, Texas, and West Virginia. If you agree that an unborn child should not be subjected to the cruel violence of having her arms and legs torn off by brute force, with steel tools that grasp, tear, and crush, please co-sponsor the *Dismemberment Abortion Ban Act*. Most of us give up on our New Year's resolutions rather quickly. But here's one that I hope you'll keep—for life.

Every human life, in or out of the womb, is precious and invested with a special dignity, having been created in God's image. But in our culture, life is assaulted. Christians should, at the same time, both love unborn babies and their mothers, and also hate what abortion does to them—and to our broken society.

Many of our BreakPoint listeners and readers are active in the pro-life movement. Many of you have walked a picket line, written a letter to the editor, or volunteered at a pregnancy care center. Many of you have given money, sacrificially, to support pro-life organizations. And yet, despite all this effort by you and millions like you and the great progress made by the pro-life community, the monstrous evil of legal abortion continues.

The statistics, 45 years after *Roe v. Wade*, are so well-known by now that, incredibly, they fail to shock us as they should. Around 60 million unborn American babies—think of it!—60 million, have succumbed to abortion since 1973. That's more than the combined populations of Texas and New York.

Each year [nearly 1,000,000] abortions are still performed in the U.S. About one in three women will have an abortion by age 45. Nearly half (49 percent) of abortions are among women and teens 24 years of age and younger. These are sobering and, if we're honest, depressing numbers.

And yet, there's good news, some really good news. First, public opinion is turning against unlimited abortion. Even young people, who are generally liberal on social issues, are quite conservative when it comes to life. A study by Students for Life of America found that just seventeen percent of Millennials support anything-goes abortion. And a Knights of Columbus poll in 2014 found an incredible 84 percent of Americans want to restrict abortion to the first three months of pregnancy or less!

Second, many states have enacted laws over the years that have restricted abortion and even forced some Planned Parenthood and other abortion providers to close their grisly death mills—in fact, 37 abortion clinics closed in 2017 alone. Praise God! And the best news of all is that God is with us on this issue, and He answers the prayers of His people. Is anything impossible for God? Jesus Christ reigns over heaven and earth, He loves the little children, and He is perfectly willing and able to answer our prayers for them. And there are some things that we're called to that will only, only be accomplished through prayer.

So let all of us who love life, born and unborn, commit to praying through this New Year, asking and expecting God to act. That's something that all of us, no matter our political, financial, or social status, can do. And so, once again, we're asking you to join thousands of others in the 21 Days of Prayer for Life.

Let us all join in prayer each day to our Heavenly Father to end abortion. Let us also pray to elect individuals that will

work to end this cancer on our society. Let us pray for that President Trump and our Governors will appoint judges that will work to preserve life not help to destroy it. We also pray for pro-life appointments to keep positions that will make pro-life decisions such as Attorney Generals of each state in the union. Let us all Pray!

ACLU Brags About Becoming “a Hub of the Anti-Trump Movement” and in Defeating Pro-Life Candidates

Pro-abortionists are competing for the title of “We hate pro-life President Donald Trump the most.” The first three to come to mind are Planned Parenthood, NARAL, and EMILY's List. Added to that list is the ACLU. Under the bated-breath headline, “ACLU to Storm 2018 Midterms,” *POLITICO* tells us, “The group aims to rival the National Rifle Association as a force on the left and become a hub of the anti-Trump movement.”

Also, as the story makes clear further on, the ACLU intends to become a hub in the anti-pro-life movement. To that end, the ACLU is “jumping into the 2018 midterms with plans to spend upward of \$25 million promoting ballot initiatives and issues in contested races across the country,” according to Edward-Isaac Dove. We're told **Most of the ACLU's spending in 2018 will be directed at Republicans, though operatives haven't ruled out indirectly going after Democrats on the wrong side of their issues, too. It will not form a PAC or endorse candidates, moves that would mean losing its 501(c)(4) nonprofit status, instead limiting its activity to promoting issues and initiatives. Among them are voting rights, the travel ban, disability rights, reproductive rights, and immigration.**

In an attempt to increase turnout, the ACLU is “committed to spending \$5 million to qualify and propel a ballot initiative in Florida to re-enfranchise up to 1.5 million convicted felons. [Executive Director Anthony] Romero said if the proposal succeeds in adding that many voters to the rolls ahead of the 2020 election, the effect will be ‘felt not just in Florida, but across the country, in terms of a very different view of the political map.’”

Dove reported **A seven-figure investment in a similar ballot initiative in another state is being finalized, Romero said. And the ACLU has begun to zero in on other races: in Kansas, where conservative Kris Kobach is running for governor; in Wisconsin, to stop Scott Walker from winning another term; and in a slate of races for Republican-held House seats that Democrats are trying to flip. In all, ACLU officials say they expect to get involved in about a dozen races, including for district attorney in California and Texas.**

Forewarned is forearmed. While it may seem a long ways away, the November 2018 elections are already in full swing.

6th Circuit Unanimously Upholds Huge Pro-Life Victory in Tennessee's "Amendment 1" *By Dave Andrusko*

We provided readers with a brief overview of a major pro-life victory in Tennessee. Today we will go into more depth in discussing the decision by the U.S. Sixth Circuit Court of Appeals to reverse a decision by a district court judge and in the process completely reject a bogus pro-abortion effort to overturn the 2014 voter passage of Tennessee's "Amendment 1."

Passage of SJR 127, which placed the proposed constitutional amendment on the ballot, and Amendment 1 itself were the top priority and legislative goal of Tennessee Right to Life for more than 16 years. The key wording of Amendment 1 was found in the beginning: "Nothing in this Constitution secures or protects a right to abortion or requires the funding of an abortion." Amendment 1 passed 53% to 47%.

A constitutional amendment was the only way around *Planned Parenthood of Middle Tennessee v. Sundquist*, a radical pro-abortion decision by the Tennessee Supreme Court in 2000 which wrongly declared "A woman's right to terminate her pregnancy is a vital part of the right to privacy guaranteed by the Tennessee Constitution."

The impact of the decision was enormous. Common sense pro-life protections were immediately stripped from state law books, including informed consent for women considering abortion, a 48-hour waiting period and requirements that second trimester abortions be performed in equipped and regulated hospitals rather than abortion facilities. Tennessee became an abortion haven; one in four abortions is performed on women who live outside of the Volunteer State.

Pro-abortion challengers, led by Planned Parenthood, argued that Tennessee's "long-established process for counting votes and ratifying amendments to the state constitution somehow violated the rights of pro-abortion voters who opposed pro-life Amendment 1," to quote Brian Harris, President of Tennessee Right to Life. The amendment required voter approval by a majority of those voting in the governor's election to become part of the Constitution. So if someone voted in the governor's race but did not cast a "yes" vote on Amendment 1, it effectively was a "no."

This process was not new—as Mr. Harris pointed out—and well publicized prior to the election. But Planned Parenthood persuaded Judge Kevin Sharp to rule that as many as 80,000 votes cast in the 2014 vote on Amendment 1 should be thrown out. This came in April 2016, just after Circuit Court Judge Michael Binkley agreed with the state that Tennessee election officials' method of counting votes was consistent with the state constitution.

Which brings us to yesterday's 27-page decision by the U.S. Sixth Circuit Court of Appeals. In summary, the questions before the court were "Whether the votes were counted incorrectly, and whether the vote counting method impermissibly infringed some voters' rights." Judges David McKeague, Richard Suhrheinrich, and Ronald Lee Gilman responded, "We answer

'no' to both questions and thus give effect to the express will of the people."

After a long discussion of (among much else) Standard of Review, Plain Language Theory, Voter-Dilution Theory, and Equal Protection, the court concluded, "Plaintiffs' arguments amount to little more than a complaint that the campaigns in support of Amendment 1, operating within the framework established by state law, turned out to be more successful than the campaigns against Amendment 1."
