## Election Results from Tuesday November 6<sup>th</sup>

The Democrats were planning on a blue wave, expecting major victories by the Democrat Party that did not happen here in Indiana. In fact, it was nearly a clean sweep for the Republicans. The Republicans also swept all the major state house races and won seven of 9 U.S. Congressional races. The major race in Indiana was for the U.S. Senate which was won by pro-life Mike Braun over the incumbent Senator Joe Donnelly. Donnelly, who claimed to be pro-life, was definitely not a reliable pro-life vote. In fact, he only voted pro-life when it was convenient for him. Braun defeated Donnelly 52-44 percent. The so-called experts were predicting this to be a very close race, but the senate race was over early in the evening.

According to Mike Fichter, president of Indiana Right to Life, “The pro-life community felt betrayed by Donnelly, who frequently took positions demanded by the abortion lobby. Unlike Donnelly, Senator-elect Mike Braun will stand for our pro-life values in Washington. Indiana is a pro-life state. We’re showing it by having two dependable pro-life voices, Mike Braun and Todd Young, represent us in the U.S. Senate. We look forward to working with Braun to protect children from abortion.”

What happened in this race may be attributed to the fact that President Donald Trump made several trips to Indiana

the Right to Life Banquet held this past Thursday at the Simon J. Graber Building. Beatley, who interviewed Dr. Bernard Nathanson prior to his death, was asked by Nathanson to tell his story to the public on how he along with other pro-abortion advocates pushed their abortion agenda and with the help of the media changed the acceptance of abortion in America. Beatley told how Dr. Nathanson saw the picture of the ultrasound of his grandchild and started him on the road to changing his thought process and gradually changed his position on abortion. Nathanson, who was the leading advocate for abortion in America, saw what he had done and resigned from the National Abortion Right League and in that letter questioned "What if we have been wrong?" which became the title of the book. Nathanson later converted to the pro-life movement and converted to the Catholic Church. He passed away in 2011 and asked Terry Beatley to tell his story.

## Senator Elect Mike Braun

Shown here is the newly elected pro-life senator from Indiana, Mike Braun. Braun, a former state representative from District 63 defeated two congressmen in the primary and defeated the incumbent Senator Joe Donnelly on Nov. 6. Braun, who was endorsed by the Indiana Right to Life PAC, had a 100% pro-life voting record. He is joined by Senator Todd Young who also is pro-life as the two Senators from Indiana. This is the first time in a long time that both senators and the governor (Holcomb) in Indiana are pro-life and in office at the same time.



## The Trump Train Rolls on in Indiana! Results from State Races

With the help of President Trump, who seems to have fired up the Republican base prior to the election, pro-life Republicans were elected all across the state of Indiana. President Donald Trump made three trips to Indiana in support of Mike Braun and that seemed to help the voter turnout not only for Braun but for other candidates as well.

Statewide Mike Braun led the ticket with more than a 10% margin over Joe Donnelly and that was followed by all three state house candidates who won by large margins: Secretary of State Connie Lawson: 59%, Auditor Tera Klutz 58% and Treasurer Kelly Mitchell with 61%.

Seven of the nine U.S. Congressional pro-life candidates won their election, and here in the 8th District Congressman Larry Buchson won re-election with a 64% majority. This could be Larry Buchson's last run as it has been mentioned that he may not seek re-election in 2020.

### Local Races

In the local races for state senate pro-life Eric Bassler (Dist. 39) and Mark Messmer (Dist. 48) were re-elected without opposition. In state representative races, Bruce Borders (Dist. 45), Jeff Ellington, (Dist. 62), Shane Lindauer (Dist. 63) and Matt Hostettler (Dist. 64) all won re-election with wide margins. Matt Hostettler was unopposed in the fall election after winning over 3 opponents in the primary in his first bid for elective office. Borders, Ellington, Lindauer and Hostettler all share parts of Daviess, Martin, and Pike Counties. All are pro-life and were endorsed by the Indiana Right to Life Political Action Committee. The pro-life movement is fortunate to have so many good pro-life elected officials in our area. On the state house level it

appears the Indiana House and Indiana Senate returned nearly all pro-life leaders and is ready for the new session beginning in January of 2019.

### **The Blue Wave Never Happened in Indiana or Other States**

While the Democrats have publicly stated for the last 6 months that a blue wave was coming in this election, they were met with disappointment in Indiana and across the United States. While the pro-abortion democrats did manage to take control of the U.S. House they lost seats in the U.S. Senate and did not do as well as they hoped in governors races. In Indiana it was a clean sweep for the Republicans, and in other states it was mixed results with the democrats making some gains but nothing like they were hoping for.

### **Democrats Now Control the U.S. House**

While the pro-life Republicans did well in the election, the major disappointment was that the U.S. House fell into the hands of the pro-abortion Democrats. The Democrats will take over in January of 2019, but not by the big majority they had hoped. Final results in the U.S. House are much less than what the Democrats had hoped for.

This will mean most likely a pro-abortion speaker of the house and pro-abortion committee chairman for various committees that will block the pro-life bills and the pro-life agenda. However, in the U.S Senate, pro-life judges are being confirmed in record numbers, and the senate will still be in the hands of the pro-life Republicans; so we have much to thankful for there.

### **Each Election RTL Gains in One Area and Loses in Another**

I guess in a final note, we seem to make progress in one election and before we can get all forces lined up we need, we lose a key battle and are not able to get the results we had hoped for. In the U.S. Senate in this last two years the republicans had a small majority, but two or three of them were not pro-life and we struggled to get things done. We did get some of these pro-choice Republicans in the U.S. Senate to vote pro-life on many of the judges and that was a big plus. We did gain some great pro-life victories in this election in the U.S. Senate, but two pro-life victories that were very close (FL and AZ) and looked to go pro-life are now slipping away as the Democrats are finding more votes to count days after the election. We will have to see how that comes out. As of this time it appears that pro-life Republicans did pick up several seats, but the exact number will not be known for some time yet.

## On Thanksgiving, Planned Parenthood Wants You to Thank Abortion Clinic Staff for Killing Babies *Micaiah Bilger*

This Thanksgiving, Planned Parenthood wants people to thank its workers for helping to kill unborn babies.

Planned Parenthood runs more than 600 facilities and sees about 2.5 million patients annually. It also aborts about 320,000 unborn babies every year, more than any other group in the U.S.

Its employees are directly involved in abortions and abortion advocacy, fighting to keep late-term abortions legal and lobbying for laws to force taxpayers to fund abortions.

And for this, the billion-dollar abortion group wants people to give thanks this November. Earlier this month, its new CEO Leana Wen sent out fundraising letters asking for donations and thank you notes to its 35,000 staffers.

“As a doctor, I know being responsible for someone’s health—sometimes their very lives—is stressful, to say the least,” Wen said. “I did my job to deliver the best healthcare I could, but hearing from the people whose lives I touched—that helped me, too.”

She pointed supporters to a form letter that thanks employees for “providing quality, supportive care” and “putting the health and rights of patients ahead of politics.”

“Your compassion and commitment are needed now more than ever, and I am proud to stand with you. Thanks for always being there for the patients who rely on Planned Parenthood every day, no matter what,” the letter concludes.

Certainly, Planned Parenthood staffers are responsible for lives—including the lives of millions of unborn babies who are killed in abortions and sometimes their mothers, too.

Abortion is Planned Parenthood’s primary goal. Former employees say it is the abortion chain’s biggest money-maker. It even has been caught giving out awards to facilities for doing more abortions. Wen also has said that expanding abortions is one of her goals as the new CEO.

Pro-life advocates should give thanks that, despite all of Planned Parenthood’s lobbying and efforts to deceive, more women are choosing life for their unborn babies. Pro-life advocates and conservative judges are being appointed to leadership positions across the country, and states are enacting strong new pro-life measures to protect unborn babies. Pregnancy centers served nearly 2 million families in 2017. Pro-life students are advocating for greater support for pregnant and parenting students on their college campuses. And more abortion workers are leaving their jobs thanks to the outreach of compassionate pro-lifers.

There is a lot to be thankful for this holiday season, but Planned Parenthood gets it wrong. Most of all, people of all walks of life should give thanks for the precious babies who are alive today because their brave mothers chose life.

## Court Permanently Stops California from Forcing Pregnancy Centers to Advertise Abortions *by Micaiah Bilger*

A long, difficult legal battle to protect pro-life pregnancy centers from being forced to advertise abortions is over in California. The U.S. Supreme Court ruled against the onerous pro-abortion law in June and on Friday, a federal court order permanently ended enforcement of the law. Alliance Defending Freedom President, CEO and General Counsel Michael Farris celebrated the final step in a statement. “California disregarded that truth when it passed its law forcing pro-life centers to advertise for the abortion industry,” Farris said. “The district court’s order puts a permanent end to that law in light of the U.S. Supreme Court’s decision in June, which rightly found that ‘the people lose when the government is the one deciding which ideas should prevail.’”

The case, *National Institute of Family and Life Advocates v. Becerra*, challenged a 2015 California law that forced about 200 pro-life pregnancy centers to advertise abortions. It fined pregnancy centers \$1,000 every time they did not advertise abortions to a client.

In June, the nation’s highest court ruled against the law, saying it “likely violates the First Amendment.” Justice Clarence Thomas, writing the opinion for the 5-4 majority, said, “The people lose when the government is the one deciding which ideas should prevail. . . . This Court’s precedents are deeply skeptical of laws that ‘distinguish among different speakers, allowing speech by some but not others.’”

Courts also have struck down similar government-sponsored speech for pregnancy centers in Austin, Texas, Baltimore and Montgomery County, Maryland, and New York City. Soon after the June ruling, the Supreme Court refused to take a case regarding a similar pro-abortion ordinance in the City of Baltimore—another victory for free speech and pro-life advocates.

# “Gosnell” Movie Profiling Serial-Killer Abortionist Stays in Top 20 Despite Censorship

The movie about Kermit Gosnell, the late-term abortionist in Philadelphia who went to prison after being convicted of the murder of three babies, briefly cracked the top 10 at the U.S. box office but also continues to face what its producers call censorship. “We have been banned, blocked, and attacked,” Phelim McAleer, who co-produced “Gosnell: The Trial of America’s Biggest Serial Killer” with his wife, Ann McElhinney, said in a statement Friday to *The Daily Signal*.

“The mainstream media refused to review the film despite a national release of a movie about a subject [abortion] that is a major political issue,” McAleer said. “NPR refused our advertising, Facebook has blocked our ads, and theaters yanked our film, even though it was a success.”

“Gosnell” has taken in an estimated \$3.2 million and was on 467 screens as of Sunday, according to Box Office Mojo, which placed it unofficially at No. 18 among all movies in theaters.

The movie opened Oct. 12 and was the No. 12 film that weekend, after hitting No. 10 for one day.


The movie tells the true story of Gosnell and how his 30-plus years as an abortion doctor ended in a case alleging multiple murders at his clinic, dubbed the “house of horrors.” Directed by Nick Searcy, the film stars Dean Cain, Earl Billings, and Michael Beach. LifeNews reported Tuesday that “movie theaters across the country are dropping and blocking ticket sales” for the movie “despite—or perhaps because of—the film’s success.”

Just before “Brianna’s” scheduled C-section, physician Brent Boles asked her if she’d allow a photo to be taken once the baby was born. He wouldn’t share any identifying information with the world, he said. Just the photo. A photo to celebrate human life.

A photo to explain just why he provides the ever-growing **Abortion Pill Reversal** regimen to women looking to undo their chemical abortions.

Brianna happily agreed, and a little bit later, a gripping photo of a newborn baby, crying under the blaze of operating room lights, was captured. Since posting the image to his personal Facebook page last week, Boles says it has garnered over 8,000 reactions and over 5,000 shares.

The Abortion Pill Reversal protocol, which saved Brianna’s child, works by reintroducing progesterone to the mother’s body up to 72 hours after the first pill is taken. The progesterone counteracts the mifepristone, restoring a woman’s natural ability to carry her baby.

Brianna, who immediately regretted taking the abortion pill, **found Abortion Pill Reversal** online, contacted the network’s 24-7 helpline (1-877-558-0333), and spoke with Boles

the same day. She was even able to get a prescription for progesterone and begin the treatment immediately.

Heartbeat International, which manages the protocol's 24-7 helpline and network of more than 500 medical providers like Boles, recently shared that Abortion Pill Reversal has **led to the births of more than 500 babies**, with another 100 on the way.

## Activist Judge Who Overturned Abortion Ban Claims Pro-Lifers Hate "Women and Minorities"

A judge who blocked Mississippi's 15-week abortion ban Tuesday claimed pro-lifers want to "control women and minorities" in his harshly-worded opinion. Appointed by pro-abortion President Barack Obama (no surprise here) in 2010, Judge Carlton Reeves of the Southern District of Mississippi argued that the law "unequivocally" violates a woman's right to an abortion. "... there is no legitimate state interest strong enough, prior to viability, to justify a ban on abortions," Reeves wrote.

Many states have approved abortion bans that protect unborn children after 20 weeks of pregnancy, which is the most they are able to do considering the U.S. Supreme Court refuses to allow states to ban abortions entirely. But Mississippi pushed the envelope by banning abortions at 15 weeks. There is just one abortion clinic left in the state, and it is located in the state capital, Jackson. It filed suit immediately after Mississippi's governor signed the pro-life law.
