2019 Right to Life Banquet Speaker Announced, Banquet will be held on Thursday Oct. 17

The local Right to Life has announced that Bradley Mattes will be the banquet speaker for the upcoming banquet which will be held on Thursday, October 17 at the Simon J. Graber Building off the Odon/Cannelburg Road. Mattes is president of Life Issues Institute, the pro-life grassroots partner of the Susan B. Anthony List Education Fund, headquartered in Cincinnati, Ohio. The organization was founded by pro-life pioneer Dr. John C. Willke in 1991.

Brad hosts *Life Issues*, a daily radio commentary on abortion and other life issues. Carried on nearly 1,200 radio outlets across the US, the program was recognized by National Religious Broadcasters with the 2016 Radio Impact Award. Brad has also hosted various half-hour radio programs on such topics as the anniversary of Roe v. Wade, adoption, men

and abortion and US Supreme Court vacancies.

Brad is president of the International Right to Life Federation and a frequent international speaker and lecturer on abortion and related life issues. He works with other countries to establish a pro-life educational and counseling presence. He also is chairman of the board of directors of the Terri Schiavo Life and Hope Network, working to protect vulnerable individuals and educate others on end-of-life issues.

The RTL Banquet will be held 2 weeks later this year in order to accommodate the speaker, who is well known in pro-life circles. Brad also served on the National Right to Life Board of Directors along with DCRTL President Louis Kavanaugh Jr., when Dr. Jack Willke served as president of National RTL. **Be sure to mark**

Movie “Unplanned” Premiere Shown Here Locally in Washington for First Showing Anywhere in USA *By Louis Kavanaugh Jr.*

When I was first approached by Indiana Right to Life to host a premiere of the movie “Unplanned” I was eager to do so, but because of commitments I was not sure if we could get it done. The premiere nationwide was to be on Thursday evening, March 28, and I was set to go out of town, leaving that morning. So when we had our phone conversation with the people promoting “Unplanned,” I asked if we could move it up to Tuesday, March 26; and to my surprise they said we could do that. That would mean we here in Daviess County were the first in all the country to premiere the movie. Mike Fichter, the president of Indiana Right to Life, agreed to come and introduce the film and say a few words just prior to the beginning of the movie. Thanks to Van McAtee of Martin County Right to Life for setting up the portable sound system for Mike to use at the theater.

Daviess County Right to Life agreed to buy the first 100 tickets and sell them on a first come first serve basis. To my surprise we sold them in just 2-3 days. With the calls we were receiving I felt this was going to be a well-attended event; but I did not expect to sell out the Indiana Theater, which held 330. Leading up to the day of the premiere the local Right to Life and the Pregnancy Care Center received numerous calls, and this heightened our expectations; and sure enough on the night of the showing we had a sellout. I’m not sure how many times the local theater sells out, but it has to be very rare. The theater did agree to run the movie again immediately after the 7:00 p.m. showing, and there were a few who did come back and view the movie. The Indiana Theater was very good to work with and was very cooperative in helping to bring the movie to Washington, Indiana.

I do want to apologize to those individuals who came a long distance to see the movie and were not able to get in and who

could not wait for the second showing. I really did not expect a sellout. I told many people there would be tickets available at the door, and sad to say there was not enough. We don’t know how many were turned away.

Movie “Unplanned” Will Not Come Back To Washington

There were just too many obstacles put in our way and we finally decided it was not worth the trouble; we will not be bringing the movie back to Washington. We are not sure who was throwing the roadblocks our way, but whatever they were it would not work out.

After the success we had with the premier back in March, we are very disappointed with this outcome; but we just ran up against too many problems and complications and decided it was not worth it. We do know that it ran for at least a month at Jasper and Evansville and other cities, but we could not get it to run here. We do hope you got a chance to see the movie, as it would be well worth your time. We apologize to those who waited for the movie to return.

Despite Numerous Roadblocks, “Unplanned” Movie Wildly Outperformed Expectations

When the weekend totals came in, “Unplanned” managed to earn more than double the projections, totaling \$6.11 million. That means it features in more theaters this weekend.

Predicting the box office returns of new theatrical releases is an inexact science. There are all manner of new measurements that industry analysts can use to gauge performance—advance ticket sales, fan interest on internet platforms, web traffic on film monitoring sites, and cast social media outreach can all be tabulated. One new data point is measuring the ratio of views to shares of the movie trailer.

Despite all of these methods, it’s still common for a title to underperform or become a hit in defiance of all the pre-release metrics. Last Friday, “Unplanned” debuted. Expectations were low. Some thought it might land in the top ten for the weekend, then quietly fade away in the following weeks.

Something else happened. The drama is centered around Abby Johnson, who was once one of the youngest directors in

Planned Parenthood. After being brought into an operating room to witness an abortion procedure, Johnson found herself watching on a sonogram as the “clump of cells” tried to evade the intrusive implements that led to ending what was obviously a human life. Abby Johnson has become an outspoken proponent for the unborn while the entertainment industry tried to silence her voice and the movie.

Predicting a Stacked Deck

The industry experts can hardly be faulted for downcast predictions. Early prognostications for the movie were always in the single-digits range, and as the weeks approached those numbers were scaled down further. By the time of the release date, predictions were no higher than \$3 million for the weekend.

“Unplanned” originated from Pure Flix, a faith-based distribution company that releases films for the Christian audi-

ence. The film was made on a small budget, features no major Hollywood celebrities, and was premiering on barely more than 1,000 screens (about one-third to one-quarter of the amount of a major wide release title). This would normally place a film in the lower reaches of the box office list. But other market forces made the estimates plunge.

The marketing team for “Unplanned” began to run into unforeseen challenges. While setting up commercials, Fox News was seen as a natural move, but when it came time to place ads on other cable networks, the film met a blockade.

Lifetime channel owner A&E Networks declared “Unplanned” commercials could not run because they were centered on offensive or sensitive content. A similar response was given by the Discovery Channel syndicate, which included The Food Network, the Travel Channel, HGTV, and others. Also declining were NBC-owned USA Network and the Hallmark Channel. One of the movie’s marketers noticed, however, the Lifetime network had pushed an interview with Scarlett Johansson where the actress promoted Planned Parenthood.

The movie ran into another unpredicted challenge: The Motion Picture Association of America (MPAA) classified the film as having offensive content and placed an R rating on it. This led to other outlets resisting the promotions. “Unplanned” was unable to run commercials on most Christian radio stations, because those normally have a policy against R-rated content.

This rating from the MPAA also carries a crude irony. Anyone under the age of 18 cannot see this anti-abortion film without a parent present. However, in many states, a girl as young as 15 years old can have an abortion performed without parental notification. Anyone explaining how this makes sense has a better grasp of paradox than myself.

Frustrated in numerous areas, the team had to resort to alternative outlets of promotion. The marketers attended the Conservative Political Action Conference (CPAC) one month ago and held a screening for attendees. Glenn Beck was asked to see the film. He initially resisted, stating that many faith-based movies were subpar and he hated giving his honest assessment to the production team. He was compelled to actually attend a screening, however, and afterward became an enthusiastic booster.

Turnout Is Fair Play

In spite of all of these challenges tossed at this title, “Unplanned” managed to draw a significant audience. When the weekend totals came in, “Unplanned” managed to earn more than double the projections, totaling \$6.11 million. That is still a low figure by large-scale studio release standards, but it was enough to have the film land in the top five for the weekend. It was a strong enough performer that the per-screen average was the third best of the entire field, out-dueling “Captain Marvel” in that statistic.

Even through the successful weekend, the movie fought for air. On Twitter, the account for the film, @UnplannedMovie, was taken down without any notification of why. After some outcry and reaching out to management the account was reinstated, albeit with tens of thousands of followers quietly re-

moved. Then another curiosity was discovered with the account. Dana Loesch, and numerous others, say they tried to follow the account only to discover they are showing as “unfollowed” moments later.

But these questionable actions on the account have not prevented a rather stark outcome. The @UnplannedMovie account managed to achieve having more followers than that of Planned Parenthood. Given the head start the infant abattoir has on the publishing platform, this is a jarring accomplishment.

One other bit of success has been announced for the movie. As it was initially expected to only last in theaters for one or two more weeks, last weekend’s success means the movie will be expanding its release. This weekend, the film will be showing on 1,700 screens.

House Democrats Block Bill to Stop Infanticide For 31st Time, Refuse Care for Babies Born Alive After Abortion *By Steven Ertelt*

Nancy Pelosi and House Democrats continue to refuse a request to allow a vote on the Born Alive Abortion Survivors Protection Act, legislation that would stop infanticide and provide medical care and treatment for babies who survive abortions. Recently House Democrats refused a vote on the bill for the 31st time — reading the same statement they have read the previous 30 occasions that claims there is no bipartisan agreement to bring the bill up for a vote. Despite the claim, Republican leaders have repeatedly asked Pelosi and top Democrats to reach an agreement for the bill to receive a vote.

This is the 33rd time in total that Congressional Democrats thwarted an attempt by Republicans to vote on a bill that would provide medical care and treatment for babies who survived failed abortions — 31 times in the House and twice in the Senate. Rep. Steve Chabot, an Ohio Republican, offered the unanimous consent request to allow a vote on the anti-infanticide bill; but Democrats, as shown below, ruled it out of order.

Republican Whip Steve Scalise and Representative Ann Wagner moved forward with a discharge petition to force Speaker Pelosi to schedule a vote. That's a petition any member of Congress can sign to allow legislation to move out of committee and to the House floor when the party controlling Congress refuses to allow a vote on it. So far, 199 members have signed on, including three Democrats.

Republicans would need all GOP members to sign the petition, along with 21 Democrats. Rodgers said she hoped poll-

ing data showing Americans strongly oppose infanticide would help change members' minds.

The blocking of a vote on a bill to stop infanticide come even as national polling shows Americans — including people who are “pro-choice” on abortion — oppose abortion up to birth and infanticide. And doctors indicate abortions are never needed to protect a woman's health and women admit having abortions on healthy babies.

And a new poll finds a massive 17 percent shift in the pro-life direction after Democrats have pushed abortions up to birth and infanticide nationally.

H.R. 962, the Born Alive Abortion Survivors Protection Act, introduced by Rep. Ann Wagner (R-MO), ensures that a baby born alive after a failed or attempted abortion receives the same medical care as any other newborn. It would also penalize doctors who allow such infants to die or who intentionally kill a newborn following a failed abortion. Every single Democrat in the Senate who is running for president voted against a bill that would stop infanticide and provide medical care and treatment for babies who are born alive after botched abortions. That includes Bernie Sanders, Kamala Harris, Cory Booker, Elizabeth Warren, Kirsten Gillibrand, and Amy Klobuchar. While they all voted to support infanticide, President Trump spoke out against infanticide in two tweets saying that it's nothing short of “executing” babies to let them die after failed abortions.

After his legal team vets the legislation, Kemp plans to sign the measure to ban abortions when an unborn baby's heart-beat begins — despite a threat by members of the Hollywood elite to boycott the state if he does. Kemp, a pro-life Republican, responded to the criticisms by saying he will sign the law as he promised voters and not be swayed by Hollywood. “We value life in our state,” Governor Kemp told WSB's Scott Slade on “Atlanta's Morning News.” The governor said he is not concerned about talk of an economic boycott if he signs the measure. “I don't believe there will be dire consequences for supporting life in our state,” Kemp told WSB.

250 Pro-Life Bills Have Been Introduced in State Legislatures in 2019, 50% Would Ban All or Some Abortions

To anyone who's been paying attention, it's clear that the pro-life movement is gaining enormous momentum. However, if you still have any doubts about pro-life progress, you need only glance at Planned Parenthood's latest press release, responding to data just published by the Guttmacher Institute, Planned Parenthood's former research arm.

According to the Guttmacher Institute, since the beginning of this year over 250 pro-life bills have been introduced in over 41 states. Almost 50% of those bills would ban abortion in "some or all circumstances," says the organization. In fact, according to Planned Parenthood's analysis, legislators in seven states have proposed bills that would *completely* ban abortion, while six states are considering or have passed "trigger bans" that would ban abortion if or when *Roe v. Wade* is repealed. Elizabeth Nash, the Senior State Issues Manager at the Guttmacher Institute, linked the glut of pro-life bills to both the conservative shift on the Supreme Court, and the increasingly open efforts of the pro-life movement to enact total abortion bans. "Energized by a new Supreme Court, anti-abortion activists and politicians have kicked into high gear their decades-long agenda to ban abortion through a series of increasingly radical and dangerous abortion bans," she stated.

Nash claimed, disingenuously, that the pro-life bills being introduced "are about exerting control and power over pregnant people." But, for the growing number of Americans who call themselves pro-life, this claim is simply absurd. The goals of the pro-life movement have nothing to do with controlling pregnant women; they have to do with protecting the lives of the unborn children that science and ultrasound technology have revealed beyond any shadow of a doubt to be just as fully alive and human as you or I.

Extremist leftist organizations like Planned Parenthood, which have built their ideology on denying or conscientiously burying basic scientific truths, are struggling to remain relevant now that those scientific truths are so undeniable and publicly accessible, thanks both to technology and the tireless efforts of the pro-life movement.

Planned Parenthood Panicking

Another immensely encouraging piece of news from the Guttmacher Institute's report is that *six states have only a single abortion facility left*. In other words, these states are on the verge of eliminating surgical abortions from their borders even *without* passing legislation banning abortions. In fact, statistics show that the number of abortion clinics across the country has plummeted over the last two decades. According to Operation Rescue, in 2018 the total number of abortion clinics in the U.S. fell to 697. That's a decrease of 79% since 1991. The *Washington Post* blames many of these closures on the successful passage of pro-life progress in legislation.

The massive growth in such pro-life legislation, and closure of abortion clinics, coincides with a dramatic decrease in the

U.S. abortion rate. According to the CDC, the U.S. abortion rate reached a historical low in 2015. That translates into millions of lives saved.

Planned Parenthood President Dr. Leana Wen sounds panicked, as well she might. "Today, the reality we live in is a terrifying one for women around the country," she claimed. As is typical of Planned Parenthood, Wen deceptively attempted to link the reduction in abortion clinics to disruptions in access to services like cancer screenings and STD and HIV testing. **In reality, pro-lifers have thoroughly debunked Planned Parenthood's past claims to offer mammograms (even the pro-abortion *Washington Post* had to admit that pro-lifers were right). Meanwhile, Planned Parenthood's own public numbers show that most of their non-abortion-related services have been declining for years, while abortions keep climbing.**

Crucially, many of the bills introduced around the country are so-called "heartbeat bills," which would ban abortion after the point when the baby's heartbeat can be detected. Let us be very clear. Every abortion should be prohibited by law since conception onwards. But these heartbeat bills are a big step in the right direction. Such bills would not only prevent the overwhelming majority of abortions from taking place but present a direct challenge to *Roe v. Wade*. If passed into law, such bills would inevitably be challenged in court, ultimately ending up at the Supreme Court, which would have the opportunity to revisit the notorious case that ushered abortion-on-demand into the United States. Pro-abortion activists clearly believe that they may very well see *Roe v. Wade* overturned within months or a few years. It's up to us, with God's grace, to ensure that their fears are well-founded.

Interestingly, even many of the massive liberal corporations which, in the past, have not hesitated to use their influence to threaten individual states if they should pass legislation that goes against the leftist agenda have declined to publicly oppose the heartbeat bills being introduced in states like Georgia. I think the reason why is obvious: public opinion is trending pro-life. Corporations that threatened Georgia for passing religious liberty legislation a few years ago know that they *can't risk* associating their brand with the killing of unborn babies.

The Pro-Abortion Movement's Worst Year Ever?

Amidst the hundreds of pro-life bills that have been introduced, a more conservative Supreme Court, a president who seems determined to fulfill his pro-life promises in the face of any amount of backlash, and the release of what may well be the most successful pro-life movie ever made – *Unplanned*, telling the story of former Planned Parenthood director Abby Johnson – the abortion industry in the United States seems set to have what may well turn out to be its worst year since the Supreme Court first passed *Roe v. Wade*.

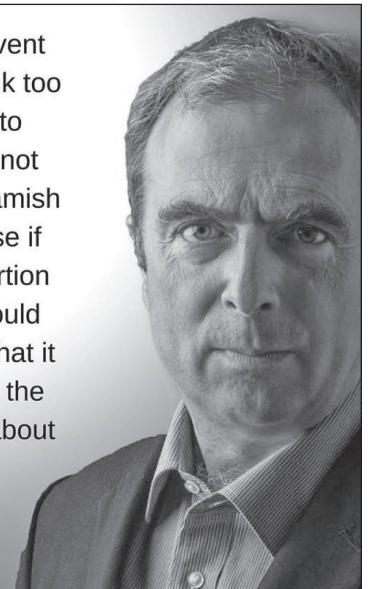

That said, pro-lifers should be wary of growing even a little bit complacent. Pro-abortion forces are terrified, and in response they are rallying their supporters and legislative allies to push back...hard. As Planned Parenthood noted in its release, the pro-life bills “have triggered a counter response from constituents and reproductive health care champions.” **This, in part, explains the glut of attempts (some of which have been successful) to pass abortion laws enshrining the most extreme versions of legal abortion in states like New York and Virginia.**

We live in chaotic times, and there is much to be worried about in terms of the state and future of our culture. However, if respect for the sanctity of human life is, as Pope St. John Paul II so often proclaimed, the necessary foundation for a healthy society, then it would seem we have great reason for both hope and gratitude: gratitude that so many lives are already being saved thanks to our country’s pro-life direction, and hope that within our lifetimes we may yet see the end of the reign of terror that is legalized abortion-on-demand.

Editor’s Note: It is time for our Catholic bishops to show their members in the church pews they will not allow Catholics who hold public positions in the community to create scandalous activity by promoting the killing of the unborn.
