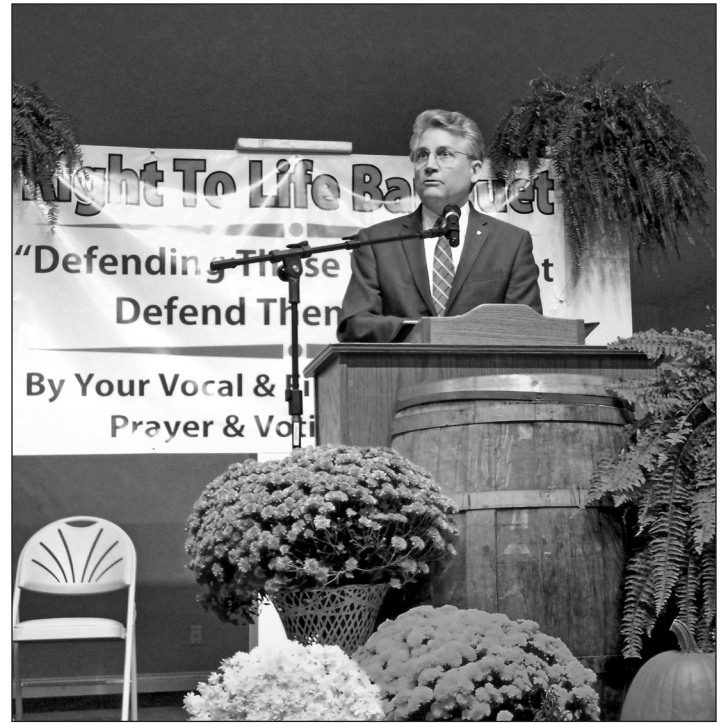
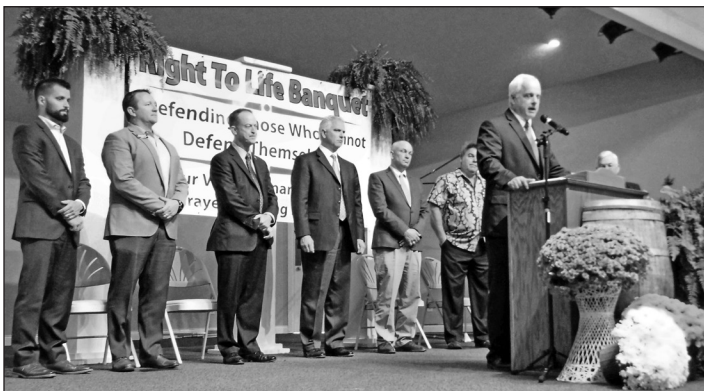
Matt and Danielle Hoffman Receive Humanitarian Award

Media Desperation Fuels Attacks on President Trump, Longing for a New Democrat to Enter the Race

First, it is impossible to exaggerate how sharp the media's knives have become. They are obsessed with defeating President Trump in 2020, and, preferably, somehow to drive him from office prior to November 3, 2020. **Nothing** is out of bounds.

Second, President Trump has amassed a formidable re-election machine, which is both bringing in extraordinary amounts of money for a second term campaign and identifying massive numbers of Americans who are favorably disposed to the president. *The New York Times* wrote about it this week and bemoaned how inadequate the Democrats' response has been.

Matthew Rosenberg and Kevin Roose write: **That campaigns are now being fought largely online is hardly a revelation, yet only one political party seems to have gotten the message. While the Trump campaign has put its digital operation firmly at the center of the president's re-election effort, Democrats are struggling to internalize the lessons of the 2016 race and adapt to a political landscape shaped by social media.**

Making a bad situation even worse, every time they assault Mr. Trump, he has turned the assault to his advantage. The Trump campaign is digitally so far in advance of any Democrat's, Laura Edelson, identified as a researcher at New York University who tracks political advertising on Facebook, quipped it's "like a supercar racing a little Volkswagen Bug."

Third, as we've talked about since almost the day after her electoral defeat in 2016, pro-abortion maximus Hillary Clinton continues to drop hints she's thinking about still another campaign. And whether it be Clinton, or someone else not in the

race, it illustrates a truth the Democrats and the major media keep trying to finesse: the current crop of Democrats running for president is desperately weak.

As the newspaper of record for Democrats and the abortion industry, the *New York Times* dutifully floated trial balloons galore this week under the headline, "Anxious Democratic Establishment Asks, 'Is There Anybody Else?'" Five paragraphs in, Jonathan Martin writes:

"With doubts rising about former Vice President Joseph R. Biden's ability to finance a multistate primary campaign, persistent questions about Senator Elizabeth Warren's viability in the general election, and skepticism that Mayor Pete Buttigieg, of South Bend, Ind., can broaden his appeal beyond white voters, Democratic leaders are engaging in a familiar rite: fretting about who is in the race and longing for a white knight to enter the contest at the last minute.

But the alternatives are, to be kind, less than powerhouses. Former Secretary of State Clinton? Former Secretary of State John F. Kerry? Former Attorney General Eric Holder? Former New York Mayor Michael Bloomberg? Ohio Sen. Sherrod Brown? To even roll these names out makes it easy to understand why former First Lady Michelle Obama's name periodically bobs to the surface.

And the more obvious the weaknesses of the current crop of Democrat candidates becomes, the more we will read stories just like Martin's and the more vicious and unhinged the attacks on President Trump will become.

The following letter has been published several times before but I think it provides worthwhile food for thought!

4. In the fourth case, you would have killed our Savior, Jesus Christ.

The main theme in these four cases is to stop and consider these situations before you decide to murder your own child or encourage someone else to do so. You may be destroying a truly great man or woman of the future. You just never know what benefit or destruction your actions may cause for future generations.

Virginia Couple Adopts After Viral Pro-Life Post Telling Expectant Mothers not to Get Abortion

A Virginia couple who went viral earlier this year with their pro-life plea to pregnant women has had their dreams answered. Blake and Sarah Thomas, of Radford, posted a photo on Facebook about nine months ago pleading with expectant mothers to not have an abortion.

“Please don’t abort. We will adopt your baby!” a sign in the photo said. They had posted the image in response to the passing of a New York bill on the anniversary of Roe v. Wade that legalizes abortion up to birth in many cases.

“We believe as Christians that we are called to love and care for orphans,” Sarah Thomas told Fox News recently.

Soon after the post went viral, the Thomas’ agreed to adopt a child, but that fell through. To their surprise and joy, the mother decided to keep and parent the baby.

However, their wishes of taking a child in were answered, and they told Fox News they are in the process of adopting an 11-year-old boy from Bulgaria.

“We recently felt God burdening our hearts for older orphans, specifically boys, who statistically are the least likely to be adopted,” Sarah Thomas said. “We’re so excited to meet him and we’re amazed by how God has already filled our hearts with love for this boy on the other side of the world that we’ve never met.”

This child won’t be the first entering their family through adoption. “God has given us a heart for the fatherless, and 3 years into our marriage we were convicted of our selfishness in waiting for children and obeyed God’s calling to become foster parents,” Sarah Thomas said.

The Thomas family – who have a 1-year-old biological son – have also adopted Kayden, 3, through the foster care. They described him as a “blessing and such a joy.”

The Virginia couple said dozens of mothers reached out to them saying they decided to keep their babies after their post on Facebook was shared over 17,000 times.

“I’m Facebook friends with many of the mothers that contacted me back in January, and my Facebook is covered with baby pictures right now which makes me so happy!”

Sarah Thomas said she had one woman write to her: “I wish I had seen your post before I aborted. I would’ve given my daughter the life she deserved, away from her abusive father, instead of deciding her fate.”

Catholic Priest Denies Joe Biden Communion Because He’s Pro-Abortion

900 Abortion Clinics Have Lost Taxpayer Funding Thanks to President Trump

Think a president can’t make much of a difference when it comes to abortion? Think again.

A new report indicates President Donald Trump has been responsible for de-funding almost 900 facilities that either perform or promote killing babies in abortions.

Last May, the Trump administration published a new proposal for Title X that would prohibit Planned Parenthood and other abortion businesses from receiving any of those tax dollars unless they completely separate their abortion businesses from their taxpayer-funded services. Federal courts eventually let the defunding rules move forward and eventually Planned Parenthood and other abortion activists left the Title X program and gave up \$60 million of taxpayer dollars.

Democrats Pass Bill to Stop Abuse of Pets, But Block Bill to Stop Infanticide of Babies

The House of Representatives today voted for the Preventing Animal Cruelty and Torture Act, or PACT bill, which will now make acts against animals a felony. The legislation, sponsored by pro-abortion Florida congressmen Ted Deutch and Vern Buchanan, would make animal abuse a federal crime with serious penalties and sentence abusers to as much as seven years in prison.

Here's more: This includes the crushing, burning, drowning, suffocation, or other violence causing serious bodily injury to animals. The new law will also revise a previous law passed in 2010 that banned "crush videos," or videos showing animals being tortured to death by humans.

Right now, federal law only prohibits animal fighting and criminalizes abusers when they create and sell videos showing animal cruelty. If passed, the new law will allow authorities to arrest animal abusers since they will now have federal jurisdiction and not be bound by state laws. The PACT Act will permit authorities to go after those who abuse domestic pets. **But when it comes to abuse — and death — of babies who survive abortions, Democrats are silent.**

Nancy Pelosi and House Democrats continue to refuse a request to allow a vote on the Born Alive Abortion Survivors Protection Act, legislation that would stop infanticide and provide medical care and treatment for babies who survive abortions.

House Democrats refused a vote on the bill 80 times — reading the same statement they have read the previous 79 occasions that claims there is no bipartisan agreement to bring the bill up for a vote. Despite the claim, Republican leaders have repeatedly asked Pelosi and top Democrats to reach an agreement for the bill to receive a vote.

Brittany Hughes of the Media Research Center pointed out the hypocrisy. "The House just unanimously passed a bill making it a federal crime to abuse an animal. And while that's all fine, well and good, this same House under Democratic leadership still refuses to take up a bill that would mandate medical care for human babies born alive following a botched abortion. Because apparently, kicking a dog is worthy of jail time, but leaving a living, breathing infant to die alone in a closet is no big deal," she said.

Tony Perkins of the Family Research Council agrees. "Maybe the DNC's strategists are out to lunch, or maybe the Left real-



ly is this shameless, but I can't wait to see some of these politicians standing on debate platforms next year telling the American people that when it comes to protecting living things: We chose cats over kids," he said. "I suppose we should also tell firefighters when they run into burning houses to look for the pets first? After all, on the Democrats' sliding scale of 'wantedness,' shouldn't we find out how loved

someone is before we decide if they're worth saving?"

Earlier this year, Democrats voted to fund infanticide. LHHS Ranking Member Tom Cole (R-OK) offered an amendment to withhold funds to any medical entity that does not ensure that any infant born alive following an abortion receives the same medical care as any other infant born at the same gestational age. Every Republican voted for the pro-life amendment to stop infanticide, while every Democrat on the committee, except Texas Democrat Henry Cuellar, voted for infanticide.

In April, Republican Whip Steve Scalise and Representative Ann Wagner moved forward with a discharge petition to force Speaker Pelosi to schedule a vote. That's a petition any member of Congress can sign to allow legislation to move out of committee and to the House floor when the party controlling Congress refuses to allow a vote on it.

So far, 201 members have signed on, including three Democrats — short of the majority necessary to get the bill to the floor for a vote. The blocking of a vote on a bill to stop infanticide comes even as national polling shows Americans — including people who are "pro-choice" on abortion — oppose abortion up to birth and infanticide. And doctors indicate abortions are never needed to protect a woman's health and women admit having abortions on healthy babies.

And a new poll finds a massive 17 percent shift in the pro-life direction after Democrats have pushed abortions up to birth and infanticide nationally. H.R. 962, the Born Alive Abortion Survivors Protection Act, introduced by Rep. Ann Wagner (R-MO), ensures that a baby born alive after a failed or attempted abortion receives the same medical care as any

other newborn. It would also penalize doctors who allow such infants to die or who intentionally kill a newborn following a failed abortion.

Every single Democrat in the Senate who is running for president voted against a bill that **//continued** on PAGE 7

King denounced local clergymen who considered him an outsider: “Injustice anywhere is a threat to justice everywhere.” The real suppression going on is that of the truth. And the National Association for the Advancement of Colored People is helping to lead the way.
