## **“Red for Ed” Organization: Beware, This Is What You Should Know!**

In the last few months a lot of news coverage has been given to a new movement called “Red for Ed.” We want to give a word of warning about this movement. No one is against a teacher’s right to lobby for more money and smaller classroom sizes, but teachers need to be aware who is behind this movement and what their goals really are.

According to *Labor Notes*, the Red For Ed movement is the brainchild of Noah Karvelis, age 24. He is a Marxist and music teacher in Littleton, Arizona, who focuses on hip-hop and praises the violent Black Lives Matter movement. Karvelis has volunteered for the Bernie Sanders Campaign and given money to the campaign.

This movement was started by “left wing” individuals who are using the dissatisfaction of teachers to promote union activism so they can defeat President Donald Trump in the 2020 election, as well as other conservative pro-life legislators who do not necessarily agree with all their agenda. Many teachers here in Indiana are caught up in this movement and don’t realize that the people behind it will be endorsing pro-abortion Democrats for state office in this year’s election and turning their dissatisfaction to their political gain. We know there are issues that need to be addressed for teachers, but be very careful who is pushing the agenda.

In February 2018, teachers launched labor actions in Virginia and West Virginia and in April 2018 they followed suit in Arizona, Colorado, Georgia, Kentucky, and Oklahoma. In May 2018 they moved on to North Carolina. This movement is picking key battleground states that Democrats need in order to put a Democrat in the White House and to push the liberal pro-abortion agenda. This is all coming from the pro-abortion teacher unions led by the American Federation of Teachers and the National Education Association. Why is the pro-life movement so concerned about what these teacher unions will do? These unions have come out in full support of abortion on demand, birth control pills in the schools, health clinics in schools—which would be nothing more than abortion referrals to abortion clinics. We could go on and on, but I think you get the idea what these teachers unions are trying to do. One exam-

ple of how far these teacher unions have gone to the left is where there was a proposal in Indiana to put the slogan, “In God We Trust” in the classroom. The executive director of the American Federation of Teachers Indiana was there to voice their opposition to the proposal.

In the far-left magazine *Jacobin* it was reported that the “energy of the ‘Red for Ed’ teacher walkouts last spring in West Virginia, Arizona, Oklahoma, and elsewhere was channeled into electoral activity by both the AFT [American Federation of Teachers] and NEA [National Education Association], with an unrelenting refrain that achieving the demands that had led angry teachers in those states to strike could only be made by electing friendly politicians.” The problem is, what other agenda items will these “friendly politicians” bring with them?

The bottom line is, the people behind this movement are “left wing” pro-abortion zealots who are working for the defeat of President Donald Trump and all conservative, pro-life legislators who do not fall in line with their agenda. Their agenda does not include pro-life principles, and you can bet that the teacher unions behind this movement will use the unrest of teachers to elect liberal Democrats in the 2020 election year.

The “Red for Ed” movement is trying to build up a war chest for the 2020 election in which the teachers union hopes to defeat President Donald Trump and many conservatives. This article is meant to be a “red flag” to conservative teachers

# President Trump Thanks Christian Voters for Their Support

In fact, for the thousands of supporters packed into Miami’s Ministerio Internacional El Rey Jesús on Friday, Jan. 3, it was probably the best explanation yet for the strong bond between Christians and this White House. Unlike the media, who can’t seem to understand the appeal of this president to his most enthusiastic base, evangelicals would say it’s simple: promises made, promises kept. America was built by churchgoing, God-worshipping, freedom-loving patriots.”

I really believe we have God on our side... or there would have been no way that we could have won,” Trump told the crowd. “People say, ‘How do you win? You don’t have the media. You have so many things against you.’ And we win. So there has to be something.”

## Trump Admin Asks Supreme Court to Uphold Louisiana Pro-Life Law Protecting Women and Babies

The Trump administration has asked the Supreme Court to protect a contested Louisiana rule that requires abortion providers to have admitting privileges at a nearby hospital. An abortion clinic and two physicians challenging the law, called Act 620, warn that two of Louisiana’s three abortion clinics will close if the regulation takes effect. On Thursday, the Trump administration said the plaintiffs have not made good-faith efforts to comply with the law, such that any adverse consequences for abortion access would be their fault and not the state’s.

The administration also asked the court Thursday to participate in the case’s oral argument, which is set for March 4. The justices generally grant such requests. A coalition of over 200 lawmakers from both houses of Congress took a far more aggressive position in their own legal filing, urging the justices to use the Louisiana dispute to reconsider *Roe v. Wade* itself. Act 620 has not taken effect. The Supreme Court put the law on hold while litigation continued in February 2019. The 5th U.S. Circuit Court of Appeals overturned a lower court ruling that blocked Act 620 in September 2018. Approximately 10,000 abortions are performed in Louisiana each year.



# Planned Parenthood Should Lose Its Non-Profit Status It Uses Our Tax Dollars to Elect Pro-Abortion Democrats

Unlike most public policy, unfettered abortion was brought to life following a Supreme Court judgment call made by seven men in *Roe v. Wade* and *Doe v. Bolton*. Without the input of the executive or legislative branches of government, all of the nation's abortion-related laws were wiped out with the judicial stroke of pen. But with the future of *Roe* in doubt, according to legal experts, reconsidering the assumptions that have been made about a billion-dollar abortion industry is timely.

Case in point, why should Planned Parenthood have a “get out of taxes free” card and avoid the financial realities that impact other businesses in America? At the very least, Planned Parenthood and the nation's abortion vendors should be taxed, just as cigarettes, alcohol, and gambling are taxed, because of the high social costs of abortion for the women subjected to them.

Pregnancy is not a disease cured by abortion, and when it comes to actual health care, Planned Parenthood offers fewer services and none (except abortion) that are not widely available elsewhere. Planned Parenthood's just released annual report for 2018-2019 shows that its abortion business is booming and that taxpayer support is at a record high at more than \$616 million in 2018. Over the past 10 years, taxpayer support of Planned Parenthood has increased by almost 70%.

Women sold abortions have risks of bleeding and exposure to disease, as well as higher risks of mental health issues, higher rates of suicide, infections, further surgeries (including hysterectomies) and infertility. Breast cancer rates are higher for women whose first pregnancy ended in abortion. A taxed Planned Parenthood would result in redistributed funds needed to address the social fallout of abortion.

Taxes impact health care providers. For example, the National Conference of State Legislators notes that a “provider tax,” sometimes termed a “fee” or “assessment,” authorizes collecting revenue from specified categories of providers. “In most states, it is used as a mechanism to generate new in-state funds and match them with federal funds so that the state gets additional federal Medicaid dollars,” and as such it can generate billions, the organization reports. In fact, 49 states and the District of Columbia use such taxes. Only Alaska has refrained.

Operating with more than half-a-billion dollars in taxpayer funds and tax-free status gives Planned Parenthood incredible room to maneuver politically.

As reported at *National Review*, “Planned Parenthood's PAC is among the most powerful lobbying groups in American politics, shelling out \$40 million last year for “public policy” and investing upward of \$175 million in such nebulous categories

as “movement building,” “strengthening and securing Planned Parenthood,” and “engaging communities.”

Considering the level of activism subsidized on the taxpayers' dime, requiring Planned Parenthood to contribute taxes is a natural step in addressing a billion-dollar industry that has been shown to negatively impact women. And frankly, taxing things – harmful or not – is a common cost of business and strongly advocated by the current crop of Democratic political hopefuls.

Sen. Elizabeth Warren wants to tax “wealth.” Former New York Mayor Michael Bloomberg wants taxes on fuel and drinks with sugar. Anyone who has booked a hotel room in recent years has seen the fat “room tax” that municipalities add to a stay in a community. Consider that “the median state tax on cigarettes has increased more than fourfold — from 34 cents in 2000 to \$1.57 in 2017,” according to a Pew study.

Industry by industry, economists can chart the impact of Uncle Sam taking a cut, and, in this presidential election season, “at least seven Democratic presidential candidates have proposed raising the corporate income tax rate” just as a cost of doing business in the U.S., notes the Tax Foundation. Why should the profitable abortion industry refuse to pay its fair share?

According to the National Council of Nonprofits, loss of tax exempt status is possible when an organization devotes “a substantial part of its activities to attempting to influence legislation,” “participate or intervene in any political campaign on behalf of, or in opposition to, any candidate for public office,” or “organized for or conduct activities that are illegal or violate fundamental public policies.”

Such as policies protecting women's health and safety in health care settings, for example? In the case out of Louisiana coming to the Supreme Court in March, the justices will ponder the question of whether an abortion vendor should be able to ignore health and safety standards designed to protect women in real health care settings.

Even if abortion were in the Constitution – and it's not – that still does not justify tax-free status or a right to ignore laws and regulations designed for public safety. A right to bear arms is in the Second Amendment, but weapons are not sold tax-free or with taxpayer subsidies.

Planned Parenthood tries to have it both ways, dodging laws and costs by hiding behind the Constitution, but fundraising and engaging with the media in the name of health care.

Given how sharply divided the country is over abortion, common ground can be found in ending the special status Planned Parenthood has achieved through its political contacts and require it operate like the health care enterprise it claims to be.



## Pro-Life Teen Nicholas Sandmann Wins Settlement from CNN for Smearing Him

Covington Catholic high school student Nicholas Sandmann has received an undisclosed settlement from CNN after the pro-abortion media outlet smeared him and a group of pro-life teens attending the March for Life. The smears against the Covington Catholic High School students began after a heavily edited video surfaced of them face to face with liberal active Nathan Phillips after the March for Life in January. Longer footage of the incident later disproved many of the claims against the pro-life Kentucky students. However, the students and their families received death threats because of the accusations, and their school was forced to close several days because of security concerns.

Now, CNN has settled the lawsuit Sandmann filed against it. The amount of the settlement with CNN was not made public at a hearing in Covington, Kentucky but it sought \$75 million for harm to Sandmann's reputation and \$200 million in punitive damages.

"CNN was probably more vicious in its direct attacks on Nicholas than *The Washington Post*. And CNN goes into millions of individuals' homes," Lin Wood, one of Sandmann's attorneys, told Fox News's Mark Levin last year. The lawsuit came after an independent investigation confirmed that a group of Covington Catholic teens told the truth about their now-viral confrontation with a Native American man in January in Washington, D.C. The report by Greater Cincinnati Investigation, Inc. states that the pro-life teens did not initiate the confrontation or use any racial slurs against Native American Nathan Phillips or the Black Hebrew Israelites group.

## Catholic Cardinal Says Denying Communion to Joe Biden Was Right, More Priests Should Do the Same!

Prominent Catholic Cardinal Raymond Burke said a South Carolina priest was "right and just" to deny communion to Joe Biden because of his abortion advocacy. # Planned Parenthood Loses 400,000 Donors After Killing More Babies in Abortions Than Ever Before

Planned Parenthood's own annual report paints a horrific picture. The abortion giant is killing more babies than ever before — but that abortion business comes at a cost, namely the support of average Americans.

Its 2019 annual report, released this week, shows it aborted 345,672 unborn babies — an increase of 3.88% over the abortions it did on unborn babies the year prior. Last year's annual report showed Planned Parenthood killed 332,757 babies in abortions, which itself was an increase of 3.51% from the year prior.

That means Planned Parenthood killed almost 13,000 more babies in abortions than the past year and almost 25,000 more unborn babies than it did two years ago — even though the abortion giant claims its main focus is merely women's health care.

Among other revelations buried in the report is the fact that the number of individual donors to the organization fell by 400,000 during the fiscal year ending last June. With Gallup polling and other surveys showing a majority of Americans are pro-life, it's no surprise that Planned Parenthood's expanding abortion business is costing it support.

Jim Sedlak, executive director of American Life League, talked with LifeNews about the loss in donors and the state of

the abortion company today. "Although Planned Parenthood falsely proclaims itself as a women's healthcare organization, the real nature of the organization received a great deal of public attention after its hiring of Dr. Leana Wen as president in November 2018 and her ultimate firing in July 2019. Wen clearly bought the healthcare lies of Planned Parenthood, and when she found out the truth about its almost total focus on abortion and politics, rebelled and was fired," he said.

He said Planned Parenthood runs over 51 percent of all the abortion facilities in the nation and now admits to committing almost 40 percent of all medical and surgical abortions. "Apparently," Sedlak continued, "as the truly abortion focus of the organization became more and more apparent, not only did Wen leave, but 400,000 individual donors to Planned Parenthood stopped giving. That exodus resulted in Planned Parenthood reporting a \$39.5 million drop in donations and a \$26.5 million drop in total income—despite the fact that its taxpayer income increased by \$53 million."

"Planned Parenthood has been lying to [the public] and government officials for decades," Sedlak concluded. "Now, its true nature as the nation's number-one killer of preborn children—especially minority children—is becoming clearer, and its individual donors are walking away by the hundreds of thousands."



## Doctors are Increasingly Euthanizing Patients to Harvest Their Organs

My very first anti-euthanasia column, published in *Newsweek*, warned that societal acceptance of assisted suicide/euthanasia would eventually include organ harvesting "as a plum to society." I was called an alarmist and a fear-monger, but alas, I was right. In Belgium and the Netherlands, mentally ill and disabled people are killed in hospitals at their request, and then, their bodies are harvested — with the success of the procedures written up with all due respect in organ-transplant medical journals.

Our closest cultural cousins in Canada are enthusiastically following the same utilitarian path, not only allowing organ harvesting to be conjoined with euthanasia, but "medically assisted death" is being boosted increasingly as "a boon."

Many of these killed organ donors *will not have been imminently dying*. They will also *generally not have been provided suicide-prevention services* as the suicidal ill and disabled who ask for euthanasia are increasingly abandoned to the "death with dignity" mindset in Canada.

## President Trump Receives Pro-Life Award

The Hosea Initiative, a prominent pro-life group has bestowed upon President Donald Trump an award for his efforts to advance anti-abortion efforts. The Hosea Initiative officially awarded President Trump their first Bernard N. Nathanson, MD "Courageous Witness for Life" Award at their gala in Washington, D.C. on Sunday Dec. 8th. The award was named after a medical professional who founded the National Abortion Rights Action League in 1969, but later became an outspoken pro-life activist.

Terry Beatley, founder and president of Hosea Initiative, told those gathered at the gala that Trump was receiving the award because he had the "courage" to stand for "the right thing." Dr. Ben Carson, secretary of Housing and Urban Development, accepted the award on behalf of the president, explaining that Trump wanted to "convey his great appreciation" for the award and for "the courage that each one of you has manifested."

"This is obviously something that is very near and dear to my heart, as a physician spending so much time working on little babies," said Carson.



# Planned Parenthood Kills 947 Babies in Abortions Every Day, 39 Babies Every Single Hour

Planned Parenthood's 2018-2019 annual report provides insight into its impact on society – particularly the unborn and their mothers. According to this giant of the abortion industry, they committed 345,672 abortions in one year's time. That means 28,806 babies were killed each month, 947 denied life every day, and 39 hearts were stilled by abortion every hour, 24/7.

Sometimes it's difficult to put these numbers into perspective, so consider this. The total number of abortions done by Planned Parenthood in 12 months is the near equivalent of the population of Honolulu, Hawaii.

Every month, their abortion body count is equal in human loss to the fatal crash of 69 fully-loaded 747-400 wide body airplanes. Each day, Planned Parenthood's human carnage by abortion results in the equivalent number of over 17 school buses full of children.

Defenders of Planned Parenthood respond that the organization does many good things besides abortion. However, their own annual report indicates non-abortion services have dramatically declined over the last decade. Their total services are down 12.6% Cancer screening and preventive services have dropped by 69%, this includes breast exams that have declined by more than 68% and pap tests that are down 72% Contraceptive services are down nearly 34%, The number of unique patients has dropped by 20%

The nation's poor and underserved – the segment of society that Planned Parenthood claims is so dependent upon their services – has a better alternative. Federally funded community health centers far outnumber Planned Parenthood in both locations and services offered. For six months alone, they served about 12-times more patients than Planned Parenthood did in a year.

Even though non-abortion services have tanked, taxpayer funding has hit a record high of \$616.8 million, nearly \$1.7 million per day. Planned Parenthood's immediate past president admitted that their "core mission" is abortion. And their dwindling non-abortion services indicate Americans are simply not getting a return on our mammoth investment.

President Trump has effectively used the power of his administration to implement the Protect Life Rule which denied Planned Parenthood \$60 million tax dollars under Title X. The evidence overwhelmingly shows it's time for congressional leaders to follow his example and end all tax funding of Planned Parenthood to significantly curtail its malignant reach. Imagine the lives that could be saved without them!
