Top Pro-Life Priests: “No Catholic Can Vote for Joe Biden”

Fr. Frank Pavone, Fr. Michael Orsi, and Fr. Stephen Imbarrato agree that even though Biden claims to be Catholic, but Catholics voters should not support him because of his position on abortion and LGBT activism.

As the November presidential election swiftly approaches, Democrat Joe Biden is looking for ways to exploit his association with Catholicism to, in the words of an Associated Press report, “claim the moral high ground” in order to “chip away at Trump’s base by appealing to pockets of conservative faithful.”

“Joe Biden is a different kind of foe than Trump has faced before: one who makes faith a central part of his persona — often literally wearing it on his sleeve,” asserted an Associated Press (AP) report published by mainstream media outlets across the country.

Yet Biden’s faith — which allows him to declare that abortion is an ‘essential healthcare service;’ to assert that if elected he will resurrect Obama-era policies that would force the Little Sisters of the Poor to violate their religious beliefs and provide contraceptives and abortifacients to their employees; to personally conduct gay weddings; and to support the overtly marxist Black Lives Matter (BLM) movement that seeks to disrupt the nuclear family — is completely foreign to vast swaths of Catholics. As the election draws nearer, Biden is racing further and further leftward, creating an ever more distinct contrast with President Trump’s strong pro-life, pro-family record.

Fr. Frank Pavone, national director of Priests for Life, said Biden’s “failure to protect the unborn puts him not only in conflict with the Catholic faith but with the Christian Gospel, the Founding principles of America, the very meaning of public service, and basic human decency. You can’t kill babies, and you can’t authorize anyone else to do so.” “Joe Biden has already, rightfully so, been refused communion,” said Father Stephen Imbarrato, an activist pro-life Catholic priest, a regular on EWTN, and a member of Red Rose Rescues.

Fr. Imbarrato recounted a litany of Biden’s scandalous positions on issues that defy his Catholic faith:

- Joe Biden supports murdering babies up till the day of birth.
- He supports the murder of the elderly, disabled, and medically vulnerable through euthanasia and assisted suicide.
- He supports any number of sexual disorders and immoral experimentations that attack Catholic marriage and family. He himself has even presided over a same-sex marriage in direct opposition to Church mandate.
- His environmental policies are built on the population control principles of abortion and contraception in direct opposition to the teaching of Pope Francis on the environment.
- He even admitted that as President he would force (bully) Catholic nuns to pay for contraception and abortion in spite of the fact that the U.S. Supreme Court sided with the conscience and religious freedom of the nuns, 7-2. This is an outright attack on our Catholic faith.

“He is a walking and talking scandal to his Catholic faith and has rightly been refused the Eucharist because he persists in separating himself from communion with the Church. He scandalizes the Catholic faith in so many ways that objectively he actually seems “anti-Catholic” in his beliefs.”

“President Trump has been a staunch defender of people of faith, and the Evangelical community is fired up and ready to rally behind him in November,” said Pastor Paula White, spiritual adviser to President Trump. “While Joe Biden radically shifts further away from the American values that Christians hold dear, President Trump continues to fight for our religious freedoms and the principles of faith that make our country great.”

Maria got sick one week and died nearly a week later on Thursday, June 18, from complications from a stroke and heart attack. We thank Maria for her defense of the unborn and may she rest in peace! Pro-Life Message by Maria “Duncheon” Knepp

The following pro-life message was written to a friend by Maria Knepp just a few weeks before she died suddenly on June 18 of 2020. Maria had strong views on the defense of the unborn and the pro-life movement.

My first defense against abortion is my faith. Abortion is a grievous act against God’s plan for us. I believe it is an act that could keep us from heaven without forgiveness. A woman can’t think that she can go in a clinic to abort her child on a Thursday morning and tell herself that she will ask for forgiveness that night. God is no fool. He knows when a heart is repentant and when it isn’t, and he gives his mercy to the sorrowful heart. Secondly, I think that a woman going in for an abortion should have to not only see an ultrasound of the life she is carrying (which I think is a law now but not always followed) but also be required to have a few weeks of counseling before she can abort. She should hear from women who have experienced her fear and uncertainty with an unplanned pregnancy and loved her child enough to give it the gift of life. She should also hear from the women who chose abortion and then spent a lifetime of regret. In my rural area, most girls who find themselves scared with an unplanned pregnancy usually have family who loves and supports them through their pregnancy and either welcomes the growing child into their family or realizes that the child would be better off in another loving home. However, I am not naive enough to think that that is always the case.

These frightened young women need to hear the stories of other women who have found themselves in the same situation, women who did not think there was any way out but abortion—but found a way. They need to see the beautiful children who were saved from abortion, either from the mother who decided to keep her child or from the mother who was given a gift of adoption. These young women should be directed to a local pregnancy center where they can find help, both financially and emotionally. That might be a good fit for you if you want to help—volunteering in some capacity at a local pregnancy center. The one in Washington is a wonderful organization, and I know some of the people who work there who are loving and passionate about helping. Now that I think of it, I would also have something to offer as a counselor. In my forty-year-career in the classroom, I could on any given year look out over my classes and see several “oops” children who surprised their mamas with their pregnancies. Yet, there sat these children—beautiful, smart, and the center of love in their families. Women considering abortion need to realize that things will be tough for a while, but the reward is worth it.

God makes no mistakes in giving life. We shouldn’t make the mistake of killing it.

National Right to Life Praises Legislation to have Planned Parenthood Pay Back Funds

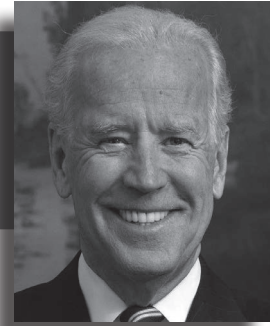

WASHINGTON, Congresswoman Debbie Lesko (R-Ariz.) introduced legislation that would require the Planned Parenthood Federation of America (PPFA) and its affiliates to return funds that they received through the Paycheck Protection Program (PPP) that is administered by the Small Business Administration (SBA).

“Planned Parenthood and its affiliates, the largest abortion providers in the country, broke the rules and applied for millions of dollars in PPP loans even though they were not eligible,” said Congresswoman Lesko.

Abortion on Demand

The 1973 *Roe v. Wade* and *Doe v. Bolton* U.S. Supreme Court decisions legalized abortion on demand throughout the United States, resulting in more than 61 million abortions.

President Trump has proven his pro-life commitment.

As president he has appointed pro-life advocates in his cabinet and administration, restored the “Mexico City Policy,” and he has pledged “to veto any legislation that weakens current pro-life federal policies and laws, or that encourages the destruction of innocent human life.”

Joe Biden supports the current policy of abortion on demand.

Joe Biden voted for the Harkin Amendment to endorse *Roe v. Wade*, which allows abortion for any reason. Joe Biden supports the Democratic platform of unlimited abortion even through birth.

The Pain-Capable Unborn Child Protection Act

The Pain-Capable Unborn Child Protection Act would prohibit abortions after the unborn child is capable of feeling pain from abortion.

In his 2019 State of the Union speech, President Donald Trump called on Congress to “pass legislation to prohibit the late-term abortion of children who can feel pain in the mother’s womb.”

When asked about prohibiting abortions after 20 weeks when the unborn child can feel pain, Joe Biden said, “I’m not going to interfere with that,” which would allow abortion through birth.

Taxpayer Funding of Abortion

President Trump opposes using tax dollars to pay for abortion. His administration issued regulations to ensure Title X funding does not go to facilities that perform or refer for abortions. He also cut off funding for the UNFPA due to their involvement in China’s forced abortion program.

Joe Biden supports using tax dollars to pay for abortion. Joe Biden says he supports elimination of the Hyde Amendment. Joe Biden voted for taxpayer funding of overseas pro-abortion organizations.

Nominations to the U.S. Supreme Court

The fundamental documents of American democracy and freedom, the Constitution and the Declaration of Independence, have given us essential principles to be respected by the courts such as the “unalienable” right to life.

The next president may have the opportunity to appoint one to three justices to the U.S. Supreme Court.

Donald Trump has appointed Neil Gorsuch and Brett Kavanaugh to the U.S. Supreme Court. These appointments are consistent with the belief that federal courts should enforce rights truly based on the text and history of the Constitution.

Joe Biden pledges that his judicial nominees would “support the right of privacy, on which the entire notion of a woman’s right to choose is based.”

With Days Until the Election, Trump Supporters Remain Far More Enthusiastic than Biden Supporters

Every election cycle is unique—one of a kind—but not many have taken place at a time in the kind of climate of unprecedented uncertainty we find ourselves in now. Add to this the unbridled hostility of most of the media to President Trump and where we stand days away from the November 3 General Election is far different from the assurances from Democrats and their media enablers that the election is Biden's to lose. Biden's bunker campaign is a reflection of his very unsteady performances. There will be an all-hands on deck blitz to "explain" why we should not have three presidential debates but only one—if, indeed, we have any. Exposure is the pro-abortion former Vice President's Achilles heel.

Biden is ahead in almost all polls but by much narrower margins in "battleground states" you have to plunge deeper to grasp the underlying reality. An absolutely classic example of what are called the "toplines" showing one thing and the crosstabs (where the pollster probes underneath the topline) showing something remarkable different is this week's AP/Ipsos poll. Here's how *HotAir's* Ed Morrissey summarizes the topline. When "leaners" are included, the poll shows a "46/34 advantage for Biden"; 8% "don't plan to vote at all"; and "and another 10% think they'll go with a third-party candidate in November."

With all due respect, these numbers are preposterous, but moving on... **Supporters of President Trump are more enthusiastic about their candidate than those who back presumptive Democratic presidential nominee Joe Biden, according to a new poll, 42 percent of Trump supporters polled described themselves as excited heading into the election, while**

31 percent of Biden supporters said the same.

The enthusiasm gap is hardly new. It's been a constant, regardless of whatever else is taking place. Despite a concerted and non-stop media campaign to discourage Trump supporters, they remain enthusiastic, far less anxious than Biden supporters about the outcome of the election, and far less frustrated.

Take this in the context of what's been discussed of late by nervous Biden partisans. First, they know that the margins in the battleground states (also called "swing states") are much, much closer than the national numbers—just as was the case in 2016.

Second, as David Catron explained, while Biden is ahead in almost every poll, when people are asked who will win, Trump prevails. **Pollsters and pundits have been nervously pondering the following question: "If Trump is behind in the polls, why do most voters say, in the same surveys say that Trump will win the upcoming election?" Several studies have shown that surveys of voter expectations are far more predictive of election outcomes than polls of voter intentions.**

A final related thought. A recent poll conducted for the Cato Institute found that far more conservative and moderates feel "The Political Climate Prevents Them from Sharing Political Views" than do liberals.

There is a hidden Trump vote. How large, no one knows. But it is there which means the election will likely remain far more closely contested than our friends at the New York Times and the Washington Post and CNN and MSNBC would have us believe.

Think about this!

If I am pro-choice, which means I support abortion, which is the killing of the unborn, will God be pleased with me? What do you think?

CNN Calls Kamala Harris "Unbelievably Smart." Calls Pro-Life VP Mike Pence a "Disaster"

On Tuesday's *CNN Tonight*, CNN presidential historian Douglas Brinkley reacted to Democratic presidential nominee Joe Biden choosing Kamala Harris as his running mate by lavishing the California Senator with over the top praise.

While gushing that Harris is "the finest prosecutor I've ever seen" and a VP pick who is "unbelievably smart, articulate and good," he declared that Vice President Mike Pence would be a "disaster" that President Donald Trump is "stuck with," and that Harris would "make mincemeat" of him.

As anchor Don Lemon presided over a segment with Brinkley and anti-Trump Republican Mark McKinnon, the CNN

host asked Brinkley if most Americans would "buy" President Trump's claim that Harris is a "radical liberal." Brinkley immediately started oozing with enthusiasm over the Democratic Senator: He further went negative on Vice President Pence, pronouncing that President Trump is "stuck with the same old thing".

What Black Lives Matter Really Stand For *By Cal Thomas*

If they really worried about black lives they would be asking why unborn black babies' lives are ended by abortion at a much higher rate than any other race. Politicians and various social justice groups have long used labels that have nothing to do with the real intent of legislation, or an organization, to dupe the public. But, to paraphrase Shakespeare, a rose by any other name is still a rose. Numerous "civil rights" bills have been passed by Congress over the years that have nothing to do with civil rights, but how many members are brave enough to point that out and vote against them?

Which brings me to the Black Lives Matter movement. How many mainstream reporters have bothered to delve into the background and founding principles of the rapidly spreading organization to which even white CEOs are contributing gobbs of money in what appears to be an attempt to protect themselves and their businesses from any potential charge of racism?

The Acton Institute for the Study of Religion and Liberty, which self-describes as "an ecumenical, nonprofit research organization that promotes the benefits of free enterprise to religious communities, business people, students and educators," has exposed the ideology of Black Lives Matter (BLM).

According to Acton Institute, the founding principles of BLM include a guaranteed minimum income for all black people, free health care, free schooling, free food, free real estate, **gender reassignment surgery, free abortion (already disproportionately high among African-American women,** "27.1 per 1,000 women compared with 10 per 1,000 for white women," but apparently unborn black lives don't matter to BLM).

Washington, D.C.'s local BLM chapter has even called for "no new jails" (which would likely guarantee an increase in crime, much of it perpetrated in black communities – see the

District's crime stats, see Chicago, see Los Angeles). BLM also demands reparations and wants to create a "global liberation movement" that will "overturn U.S. imperialism (and) capitalism."

According to The New York Post, "Black Lives Matter co-founder Patrisse Cullors said in a newly surfaced video from 2015 that she and her fellow organizers are 'trained Marxists.'" Breitbart News, a conservative syndicated news website, reported that "Cullors, 36, was the protégé of Eric Mann, former agitator of the Weather Underground domestic terror organization, and spent years absorbing the Marxist-Leninist ideology that shaped her worldview."

Driving through what appeared to be a mostly white neighborhood in Washington, D.C., last weekend I was surprised, though I probably shouldn't have been, to see quite a view "Black Lives Matter" signs on front lawns and on cars. A few friends have posted the BLM sign on their social media pages. **I wonder if any of these people know the background and goals of the movement, or the radical ideology behind it.**

There are a growing number, especially among the young, who have been "educated" in our once great universities by some professors who support the BLM movement and promote similar or identical ideologies. Part of what they are taught is that America began as a white, slave-owning patriarchy and that slaves actually built America. They quickly absorb this, and then come home to tell their parents they are part of the problem.

This is a major reason school choice is important if the nation is to be preserved. It should also be obvious that parents must be more selective in where they allow – and in many cases pay for – their children to attend colleges and universities and choose one where their values are strengthened and the nation not undermined.

Black lives matter because like all lives, everyone is endowed with unalienable rights. But the BLM movement might be more harmful than helpful to African Americans. BLM's foundational principles and goals seem closer to those of China and the former Soviet Union. If more people understood that, they might wake up and realize that the United States, as Ronald Reagan used to say, is only one generation from losing it all.

If You Don't Vote for Either Candidate in the Upcoming Presidential Election Who Would Benefit?

President Donald Trump Is Right about Mail-In Ballots *By Cal Thomas*

I begin with a personal story to make a greater point. Two weeks ago, I mailed an 8-by-10-inch envelope from a Miami post office to an address in New York State. The postage was correct, as was the address and ZIP code.

One week passed and the recipient emailed to say the envelope had not arrived, so I mailed another one. Last week, he wrote to say that the second one had arrived. A few days after that he wrote again to say the one mailed earlier had finally been delivered after a 10-day delay. Normally, a first class mailing would not have taken more than three business days.

Multiply my experience by the 100 million that could be expected from an all-mail-in election and the problem should be obvious.

President Trump has said the potential for fraud with all mail-in voting is enormous. While he has said absentee ballots are safer, *The New York Daily News* reported "Systematic failures at the state Board of Elections and U.S. Postal Service resulted in nearly one in 10 absentee ballots cast in the June 23 primary being invalidated." That comes out to 84,000 out of nearly 319,000 ballots cast.

Many Democrats claim the fear over mail-in ballots is misplaced, but the evidence proves otherwise and in close elections, especially presidential elections, a few votes either way in key states can decide the winner.

In the 2018 congressional election, officials in Broward County, Florida, had trouble finding 2,040 ballots. The South Florida Sun-Sentinel reported, "The County's eternally beleaguered Supervisor of Elections, Brenda Snipes, said they either misplaced, misfiled, or mixed in with another stack."

The Associated Press recently reported: "Hundreds of thousands of applications for mail-in ballots that a voter-advocacy group sent to voters in Virginia had the wrong return addresses, adding another complication for state election officials who are already hard-pressed to pull off a smooth election in a pandemic."

In Clark County, Nevada, which includes Las Vegas, the Public Interest Legal Foundation, a conservative election integrity watchdog firm, reports, according to the *Western Journal*, "universal mail-in balloting resulted in one out of every six ballots being 'undeliverable' in a recent primary...over 223,000 ballots bounced because the addresses were incorrect or outdated."

"CBS This Morning" ran a small test on mail-in ballots. The program set up a P.O. Box and sent 100 mock ballots to it. A few days later the show sent 100 more. Only 97 percent of the first batch arrived after a week and 21 percent of the second batch had not arrived after four days. The show stated the obvious that

in close elections such incidents could make a difference.

Then there is the possibility of fraud. During the 2018 election campaign, *The New York Post* reported, "Homeless people on Los Angeles' Skid Row were bribed with cash or cigarettes in exchange for bogus and forged signatures in a 'large-scale voter fraud scheme,'" according to state prosecutors.

There are many other examples of voting problems in several states. Republicans are mostly opposed to universal vote-by-mail.

The Heritage Foundation, a conservative think tank based in Washington, D.C., claims the process invites fraud and cite over a thousand voter fraud convictions and a study showing that 28 million mail-in ballots are unaccounted for over the last decade.

For these reasons, mail-in balloting should be limited and thoroughly checked. Voters can practice all the things medical experts tell us to do and vote in person. It is a civic duty and a privilege. It will also help reduce errors and fraud and improve the credibility and acceptance of the results.

House District Races in our Area: In the **45th House District** Bruce Borders is unopposed at this time after winning a primary battle. In **House District 63**, pro-life incumbent Shane

Lindauer is being challenged by Teresa Kendall. In **House District 62**, pro-life incumbent Jeff Ellington is being challenged by Alyssa Bailey. In **House District 64**, pro-life incumbent Matt Hostettler is being challenged by Ian Gamroth. In many of the house races this year teachers have been recruited to run for office in hopes of breaking the hold of the Republicans in the Indiana House and Senate. As we in the pro-life movement know, the teachers union has not been exactly friendly to pro-life legislation, and their goals are not the same. The pro-life incumbents are expected to get the endorsements in their house races this fall because of their pro-life voting record.

David Daleiden Asks Court to Dismiss Bogus Criminal Charges for Exposing Planned Parenthood

The unjust prosecution of David Daleiden continues today as the pro-life advocate fights in court to get the bogus criminal charges dismissed that were filed against him for exposing Planned Parenthood's sale of aborted baby parts. Daleiden recently pleaded not guilty in California Superior Court to nine felony charges involving eavesdropping, falsifying documents and recording people without their consent.

Former California Attorney General Kamala Harris and current Attorney General Xavier Becerra, both Democrats who received campaign donations from Planned Parenthood, have been prosecuting Daleiden and fellow investigator Sandra Merritt.

However, Thomas Brejcha, founder, president and chief counsel of the Thomas More Society, which represents Daleiden, says undercover journalists and whistle-blowers have been celebrated for similar work, writing: "... about the time that Daleiden published his findings, animal rights activists were praised for documenting abuse in the poultry industry. Unlike in Daleiden's case, Harris launched probes of the poultry industry and didn't charge the reporters." He said Daleiden used standard undercover journalist techniques in his investigation of Planned Parenthood.

Even legal scholars and news outlets that support abortion have slammed Harris and Becerra for prosecuting Daleiden and Merritt. Brejcha said law professors Sherry F. Colb and Michael C. Dorf criticized the state for pursuing criminal charges against Daleiden because the case could "cripple investigative journalism" as a whole.

"Whatever the precise facts of this case prove to be, the prosecution has broader implications, and not just for abortion and anti-abortion speech," they wrote in a column for CNN. "Undercover exposés play a vital role in informing the American public of important facts that would otherwise remain hidden."
