Liberal Democrats Win Two Georgia Senate Seats, Turn U.S. Senate to Democrats

On January 6, the Democrats picked up two senate seats in Georgia and now have control of the U.S. Senate at 50-50 with Kamala Harris having the deciding vote. Coverage of Capitol Protests by Mainstream Media Called Out

During the months of anti-police violence, prominent voices “excused” the violence when it fit their agenda, says Tim Graham.

The media went out of its way in 2020 to paint sometimes-violent protests across the nation as mostly “peaceful,” but finally came around on the Wednesday January 6 demonstration at the U.S. Capitol to the notion that mayhem and anarchy is always unacceptable; all it took was Trump supporters causing the chaos to spark a swift change of heart.

“It’s not hard to find prominent voices on the left who are suddenly finding lawlessness inexcusable, after suggesting it was excusable if it forwarded their agenda. They used words like ‘rebellion’ to glamorize unrest,” according to Media Research Center executive editor Tim Graham.

Washington, D.C., police said late Wednesday that the security breach at the U.S. Capitol resulted in four deaths – including a woman who had been shot – and at least 52 arrests. The tragic scene has been widely condemned by just about anyone with a public platform – a stark difference to how last summer’s protests over police brutality were reported.

Last year MSNBC anchor Ali Velshi, who was reporting live from Minneapolis following the death of George Floyd, told viewers that the situation was “not generally speaking unruly” – while standing in front of a burning building.

ABC News was criticized in July for describing a California protest that featured demonstrators setting fire to a courthouse, vandalizing a police station, and shooting fireworks at police officers, as “peaceful.” CBS Evening News anchor Norah O’Donnell said “mostly peaceful” protests would cost \$1 billion to \$2 billion in claims as a result of damage from looting and arson, and CNN’s Omar Jimenez was famously reporting live in front of a raging fire amid Kenosha, Wis., chaos and the headline at the bottom of the screen read, “FIERY BUT MOSTLY PEACEFUL PROTESTS AFTER POLICE SHOOTING.”

CNN’s Chris Cuomo even asked viewers during the BLM rioting/looting, “Please, show me where it says that protesters are supposed to be polite and peaceful.” But the CNN host felt differently on the Capitol riot. “Protestors use speech. Angry. Not peaceful often ... outraged, cursing ... and that is protected. Sedition is not. Criminality is not. These were mobs that trashed the Capitol and got light treatment for it. This is where we are. And it is ugly,” Cuomo tweeted. Do we have a double standard here? I think so! Cuomo, who was criticized on social media as old clips were unearthed, defended himself by saying “false equivalency BS is killing us.”

Graham believes the chaos that played out on live television was so serious that “it’s no time for double standards” from the press, who should have condemned violence all along. “It’s time for standards, and respecting the home of our Congress is the lowest standard for American civilization. We should insist that trashing an Apple store is inexcusable. Trashing our Capitol is even worse,” Graham said.

Grabien Media founder Tom Elliott put together a montage of media members endorsing political violence from Antifa that further illustrates the hypocrisy.

Conservative strategist Chris Barron told Fox News that “violence is always wrong” but “the mainstream media spent months telling people that it was a legitimate political tool” until that narrative became inconvenient.

“They whitewashed the violence, they encouraged it and now they felt outrage when folks who they politically disagree with act in the exact same way,” Barron said.

President and Others Shut off from Social Media Platforms, Free Speech Under Attack!

In what may be considered an attack on free speech, President Trump and other citizens have been shut off from various social media platforms. After Twitter censored him, Trump posted this statement on the official governmental account of the office of President, @POTUS. It was later shut down too!

President Trump stated: **“As I have been saying for a long time, Twitter has gone further and further in banning free speech, and tonight, Twitter employees have coordinated with the Democrats and the Radical Left in removing my account from their platform, to silence me—and YOU, the 75,000,000 great patriots who voted for me,”** Trump said in a statement. “Twitter may be a private company, but without the government’s gift of Section 230 they would not exist for long,” he added. “I predicted this would happen. Shortly after President Trump posted the statement, Twitter suspended that account also. “Using another account to try to evade a suspension is against our rules,” Twitter said in a statement to news outlets. “We have taken steps to enforce this with regard to recent Tweets from the @POTUS account.”

“For government accounts, such as @POTUS and @WhiteHouse, we will not suspend those accounts permanently but will take action to limit their use.”

Facebook and Twitter have lost a combined \$51 billion in market value since banning President Donald Trump from their platforms as Americans across the country divest themselves from the companies’ stock offerings.

It is truly a sad day in America when these liberal elements have taken power to the extreme so as to silence conservative speech not only from the president but other conservative pro-life people. Crosses Erected By Right to Life at Grace Baptist Church Lawn



Pictured here are white crosses with a heart on them that were recently erected on the lawn at Grace Baptist Church on Highland Avenue and Troy Road. The crosses and signs were donated to the Daviess County Right to Life by Dr. William Phillips of Washington. The crosses and signs have been on display in Dr. Phillips' lawn on the east side of Washington for many years. He recently donated the crosses and the large signs to the local Right to Life group and felt a new location might create more visibility for the display and get more recognition. The crosses represent the infants killed by abortion, and the red heart on each cross signify that a child that dies of abortion had a beating heart.

According to Louis Kavanaugh Jr., president of Daviess County Right to Life, "We are thankful for the donation by Dr. Phillips, as this display signifies a cemetery for the unborn. It represents that in each child that dies from abortion there was a heart beating that has been snuffed out and we need to mark that passing." Also donated with the 30 white crosses were two 4 by 8 signs, one of which reads "Choose Christ & Choose Life" and the other one reads "Every 24 Seconds, a Baby's Heart Stops Beating." This display of crosses on the lawn at Grace Baptist Church is the first location selected for this display as it is the intention of the Right to Life to move them to various locations around the county. This display can either be put on a church lawn or can be put on an individual's private property if they desire. Also three large white crosses were donated by Dr. Phillips, and they have been put permanently there at Grace Baptist Church on the Troy Road Side of the Church. 
Right to Life Office to Remain at Grace Baptist Church

Pro-Life Leader Joe Scheidler Passes Away, He Inspired Pro-Life Americans to Vocally Oppose Abortion

Pro-life pioneer Joe Scheidler, who has often been described as the "Godfather" of the American pro-life movement, passed away on January 18th. Scheidler was heralded as one of the early pro-life leaders to participate in protests at abortion clinics and to encourage Americans to vocally oppose abortion by speaking out for unborn children at the very abortion centers where they are killed.



Scheidler began fighting for the rights of the unborn even before the infamous Roe v. Wade decision. After working for other pro-life organizations for several years, Joe founded the Pro-Life Action League to serve the need he saw for pro-life Americans to take bold, direct action to save babies from abortion in their own communities. His 1985 pro-life activists manual, "CLOSED: 99 Ways to Stop Abortion," put pro-lifers throughout the United States and the world to work effectively fighting abortion. Scheidler's commitment and determination have been an inspiration for generations of pro-life activists who have followed.

Scheidler was so effective in protesting abortion businesses that the feminist group NOW filed a RICO lawsuit against him and accused him of being an illegal mobster targeting abortion centers. The Supreme Court considered the lawsuit and subsequent legal actions three times and ultimately decided in his favor. Joe Scheidler died of pneumonia at the age of 93 at 9:45 a.m. on Monday, January 18, 2021, surrounded by his family at his home on Chicago's northwest side. Joe is survived by his wife, Ann, seven children, twenty-six grandchildren, and one great-granddaughter.

Editor's Note: Joe Scheidler was the Right to Life Banquet Speaker in Daviess County on two separate occasions in 1987 and again in 1996. He was a dedicated pro-life individual and we are saddened at his passing but know that his reward in heaven will be great because he stood up for the unborn. May God grant him his eternal reward.

45 Abortion Clinics Closed in 2020, 79% of All Abortion Clinics Open in 1991 Have Shut Down

A total of 45 abortion facilities closed or halted abortions nationwide in 2020, leaving one state without an active abortion facility, according to a survey conducted by Operation Rescue.

Missouri has become the first Abortion-Free State—at least in practice for now. The embattled Reproductive Health Services Planned Parenthood in St. Louis was the last abortion facility in Missouri. It remains open, but Operation Rescue has confirmed that no abortion appointments have been available there for months, and none are available anytime in the foreseeable future. All abortion appointments are now being referred to the Fairview Heights Planned Parenthood facility across the Mississippi River in Illinois.

“While the RHS Planned Parenthood remains open and licensed for abortions, we confirmed that none are being done there. That means this facility is currently acting only as an abortion referral center. There is no operational abortion facility in the state of Missouri, making it the first Abortion-Free State at this time,” said Operation Rescue President Troy Newman. “It is obvious that Planned Parenthood of the St. Louis Region, which operates RHSP, seeks to avoid having to comply with Missouri’s strong pro-life laws, and has opted to abort in Illinois where abortion facilities are essentially unaccountable. This shows a gross disrespect for the lives and safety of the women Planned Parenthood purports to serve.”

Other noteworthy facts were revealed by Operation Rescue’s survey of every U.S. abortion facility.

- There are currently **706** active abortion facilities in the U.S.
- Since Operation Rescue began tracking the number of abortion facilities in 2009, **surgical abortion facilities** have decreased in number by 255.
- Since 1991, there has been an incredible **79 percent drop** in the number of surgical abortion facilities nationwide.
- There was a **net loss** of four U.S. abortion clinics overall in 2020.
- The number of Planned Parenthood abortion facilities **decreased in 2020**.
- 2020 was the first year that Operation Rescue tracked the number of facilities that distributed abortion drugs via telemedicine. The survey found that **69 locations**, representing **9.78 percent** of all abortion facilities, now operate telemedicine abortion programs.
- Each year, Operation Rescue conducts a nationwide survey that involves contact with each abortion business in the U.S. The information gathered about the abortion clinics and their practices represents the most current and accurate data available.
