
## In Memory of Henry Bennett

And instead of respecting differences in beliefs about marriage and sexuality, **the Equality Act discriminates against people of faith precisely because of those beliefs.** In the process, the Equality Act codifies the new ideology of "gender" in federal law, dismissing sexual difference and falsely presenting "gender" as only a social construct.

The Equality Act:

- exempts itself from the bipartisan Religious Freedom Restoration Act, in an explicit and unprecedented departure from one of America's founding principles, thereby infringing on religious freedom and making it more difficult for individuals to live out their faith
- forces religiously operated spaces and establishments, such as church halls, to either host functions that violate their beliefs or close their doors to their communities
- requires women to compete against men and boys in sports, and to share locker rooms and shower facilities with men and boys

# What is the Mission of Right to Life Compared to Pregnancy Care Centers?

*Note: We feel there are some who do not know the mission of the Right to Life and Pregnancy Care Centers and they are confused when the Right to Life gets political. We hope to enlighten you—read below.*

The mission of the Right to Life organization is different from the Pregnancy Care Centers. The Right to Life organization works with our elected officials to pass legislation that protects life from the dangers of abortion, infanticide, and euthanasia, and we also work to protect pro-life laws that are already on the books. This is to protect their lives from conception to natural death. We also inform our members on how elected officials stand on these issues. We also let our members know how our elected officials vote on these issues and their public statements along with their response to Right to Life questionnaires. We receive this information from our National and Indiana Right to Life offices who canvass those running for election to office. This is done by the State and National Right to Life groups and they in turn pass that information on to us. We do not contribute to any political campaigns. Our members also pray and council outside at the Planned Parenthood chambers in Bloomington, Indiana. So as you can see we are in the political world.

The Pregnancy Care Center has a different mission: they support those with troubled pregnancies in various ways. They do not get into the political process. Many of their volunteers and members are also members of the Right to Life. The Washington Pregnancy Care Center was started by Daviess County Right to Life, and we support their work financially. Recently the Washington Pregnancy Care Center has changed their name to First Choice Solutions.

There are some people who want to put down the Right to Life organization for being too political and being “one issue,” but please note why our mission is so different from the PCC. They are a C3 organization (education) and they have their mission and we have ours. We are a 501-C4 organization that deals with advocacy and lobbying to pass laws or change existing laws as well as a 501-C3.

**While some detractors of the Right to Life organization call us “one issue,” we feel they are using this as an excuse to**

**support their favorite pro-abortion candidate, and they are trying to justify their action. We feel the abortion issue and issues pertaining to this horrible evil are THE most important life issue, and all other life issues pale in comparison; no other issue is close to that level of importance.**

**I would like to quote an editorial from the National Catholic Register (Sept. 27, 2020) which sums it up best when it talks about issues: Immigration, hunger, and poverty are all important too, but none of them will result in anywhere near the loss of human life that abortion does. Not even close. Nor do any of these other issues make parents complicit in the deaths of their own children. Little wonder the U.S. Bishops have listed abortion in the United States as “our preeminent priority” on human life, and it should be treated as such when we vote. When a group of American bishops discussed abortion as the preeminent priority with Pope Francis, he replied: “Of course it is.”**

It is not morally possible for any good Christian to support candidates for public office who support abortion, euthanasia, fetal stem cell research, or human cloning. There is no way around this, no justifications whatever. **While some people try to justify their support for abortion candidates by saying this is just one issue—sorry, it is “the most important issue” and you cannot deny that abortion is intrinsically evil.**

If you support candidates who support abortion you need to think about this. A person must be very careful of their actions when voting. Will I be held responsible and accountable for my civic actions while voting for candidates who support abortion? Is the abortion issue foundational to all human rights issues concerning individual freedom and the Right to Life? I think we know the answer to these questions.

I have worked at this since 1978 and it is discouraging to me that so called “good Christian people” will criticize the Right to Life organizations when they are really looking for an excuse to support their favorite pro-abortion candidates.

# CNN Director Admits Network Engaged in “Propaganda” to Defeat President Trump

An undercover video released today shows a top CNN official admitting the news network engaged in “propaganda” to defeat President Donald Trump and assist the campaign of abortion advocate Joe Biden.

Project Veritas released a new video today exposing CNN Director Charlie Chester, who admitted that his network engaged in propaganda to benefit Biden’s candidacy during the 2020 election to the detriment of then-President Trump. Chester also said CNN has a pre-determined agenda when reporting on COVID-19 and climate change.

“Look what we did, we [CNN] got Trump out. I am 100% going to say it, and I 100% believe that if it wasn’t for CNN, I don’t know that Trump would have got voted out... I came to CNN because I wanted to be a part of that,” Chester is quoted as saying in the video. The CNN official admits the network tried to falsely smear Trump as mentally incompetent.

“[Trump’s] hand was shaking or whatever, I think. We brought in so many medical people to tell a story that was all speculation — that he was neurologically damaged, and he was losing it. He’s unfit to — you know, whatever. We were creating

a story there that we didn’t know anything about. That’s what — I think that’s propaganda,’ he says. “We would always show shots of him [Biden] jogging and that [he’s] healthy, you know, and him in aviator shades. Like you paint him as a young geriatric.” Chester indicates CNN is now moving on from defeating Trump and propping up Biden to pushing a leftist agenda about climate change, which usually includes support for killing more babies in abortions.

“I think there’s a COVID fatigue. So, like whenever a new story comes up, they’re [CNN’s] going to latch onto it. They’ve already announced in our office that once the public is — will be open to it — we’re going to start focusing mainly on climate,” the CNN director said. “It’s going to be our [CNN’s] focus. Like our focus was to get Trump out of office, right? Without saying it, that’s what it was, right? So, our next thing is going to be for climate change awareness.” “It [COVID] will taper off to a point that it’s not a problem anymore. Climate change can take years, so they’ll [CNN will] probably be able to milk that quite a bit...Climate change is going to be the next COVID thing for CNN...Fear sells,” he added.

# Joe Biden Puts Pro-Life Groups on Domestic Extremist List, Calls Pro-Life People “Violent”

Joe Biden’s administration included pro-life activists on a list of “domestic violent extremists” in a new report from the Office of the Director of National Intelligence. The *Christian Post* says this report, published March 1, warned that 2021 could be a bad year of violent extremism in America.

It pointed to racial issues, “perceived government overreach,” “narratives” of election fraud, the COVID-19 pandemic and “conspiracy theories promoting violence” as motivations for potential heightened violence.

The report did not name specific groups or individuals, but it did identify several “threat categories” of extremists, including pro-lifers and abortion activists, animal rights activists, anti-government groups and anarchists, and racist groups.

“Abortion-related domestic violent extremists” have “ideological agendas in support of pro-life or pro-choice beliefs,” the report states. The office did emphasize that “mere advocacy of political or social positions, political activism” and “use of strong rhetoric may not constitute violent extremism, and may be constitutionally protected.”

It defined “domestic violence extremists” as “U.S.-based actors who conduct or threaten activities that are dangerous to human life in violation of the criminal laws of the United States or any state; appearing to be intended to intimidate or coerce a civilian population; and influence the government by mass destruction, assassination, or kidnapping.”

The Obama administration also described pro-lifers as domestic terrorists in a 2012 report from the Department of Homeland Security. Pro-life advocates are peaceful, and pro-life organizations condemn violence and other illegal activities just as they condemn the legal violence of abortion against unborn babies.

Often, pro-lifers are targets of harassment, threats, and violence. LifeNews.com recorded nearly 200 incidents in 2019 and 2020, including a bomb threat during a 40 Days for Life event in Minnesota, the brutal attack of an older pro-life man outside an abortion facility in San Francisco, a pro-life banner set on fire inside a Western Washington University building, and a man charged with pulling a gun on pro-lifers outside a Delaware abortion facility.

# Easy to Vote and Hard to Cheat

Experience has shown that the volume with which abortion activists complain is an accurate indicator of the effectiveness of our efforts. The frenzied reaction to Georgia's fair election legislation should be instructive for all Americans.

Georgia's bill is just the tip of the spear, but a major battle looms ahead. Without fair and transparent elections, our efforts to advance legislation to reverse *Roe v Wade* would be a futile effort.

The Georgia law SB 202 makes a full-court assault on voter fraud, and our opponents are livid.

Adversaries, including President Biden, have flatly lied about what the law does, claiming it's racist. Biden actually stated SB 202 is "Jim Crow in the 21st century," calling it "un-American" and "sick." The Washington Post publicly called him out, stating his accusation wasn't true—awarding him four Pinocchios—but that hasn't stopped the president or his administration from repeating the falsehoods.

Here's some of what SB 202 actually does:

- Ballot applications can only be mailed to voters who request them (as opposed to simply sending every registered voter a ballot application)
- Require a photo ID verification for absentee voting.
- Provide absentee ballots to all qualified voters who request them, but ends mass mailings of absentee ballots or request forms.
- Verify the accuracy of voter registration lists.
- End private funding of election officials and government agencies by far-left individuals or corporations like Facebook, Twitter, and Google.
- Provide complete access to the election process for election observers.

The law does not disenfranchise voters, but instead facilitates easier voting while making it harder to cheat.

In direct contrast is the Democrat-sponsored legislation called For the People Act, nicknamed "Corrupt Politicians Act" by many of its critics. Substantial criticism springs from state-level election officials (many of them Democrats), some who are not shy to express their expletive-laced objections.

The bill would:

- Force a dangerous federal takeover of our elections, authority that has been given to states by the constitution.
- Void laws in 36 states requiring voters to present ID
- Render null and void any other laws developed over decades to enfranchise voters.
- Create a system that would force states to register illegal aliens.

- Establish unverifiable forms of absentee voting.
- Eliminate key safeguards.
- Force taxpayers to fund a New York City-style campaign system.
- Create an environment allowing con artists to cast multiple fraudulent votes.
- Allow ballot trafficking, that is collecting ballots and depositing them in drop-off locations with little accountability.

According to West Virginia Secretary of State Mac Warner, the bill would disenfranchise voters in 31 states. Those impacted include voters in the military or overseas, those with disabilities, hospitalized voters, or voters fleeing a natural disaster. Should the Democrats prevail, beltway experts say it would have a devastating impact on fair and open elections that would undermine the American voting system.

## Why is the Right to Life Concerned about Voter Fraud and Voter Irregularities?

The Democrats want to open it up where fraud is more likely to happen; and it favors Democrats, and the Democrats are 100% pro-abortion. ## Actress Sharon Stone Writes About Her Abortion

A number of times in recent years, I have opened a celebrity biography, only to find within its pages a reference to abortion. Sometimes it is the first time that the abortion has been shared publicly. In her new memoir, *The Beauty of Living Twice*, Hollywood actress Sharon Stone reveals that, at the age of 18, she had an abortion.

Stone writes that she and her boyfriend traveled out of state to Ohio to undergo the abortion.

“I was bleeding all over the place, and far worse than I should have been. But this was a secret, and I had no one to tell. So I stayed in my room and bled for days. I was weak and scared and then just weak.”

I am struck by the depth of the trauma that Stone endured alone. And it underscores the importance of reaching out with compassion to pregnant women who may feel abandoned at their hour of greatest need.

It appears there was nothing quick and easy about Stone’s abortion. The physical aftermath continued for some time. It is heart wrenching to think about a young woman who suffers in isolation, carrying a burden no one was ever meant to bear. Research shows that the after-effects of abortion can be profound. Physically, a woman can suffer from maladies such as a perforated uterus or excessive bleeding. Emotionally, a woman can endure great hardship as a result of abortion trauma: everything from depression to eating disorders.

With nearly 900,000 abortions performed each year, one wonders about all those other women who have been traumatized. They may never write a best-selling book, but their stories need to be heard and shared.

Only when we begin to listen to the true stories of grief following abortion can healing begin.

## Indiana Senate Passes Pro-Life Bill Saving Babies From Abortion

The Indiana Senate passed life-saving legislation April 6th to ensure mothers receive information about their unborn baby’s development and the abortion pill reversal procedure before going through with an abortion.

State House Bill 1577 passed by a strong majority in a 36-14 vote, with three Republicans joining Democrats in voting against it. After a concurrence vote in the House, the bill will go to Gov. Eric Holcomb’s desk.

Sponsored by state Rep. Peggy Mayfield, R-Martinsville, the bill would require abortion facilities to inform mothers about the abortion pill reversal procedure, which can reverse the effects of a drug-induced abortion and may save her unborn baby’s life. It also would require abortion facilities to give women a photo of her unborn baby’s ultrasound image at least 18 hours before the abortion.

- forces faith-based charities that serve all people to violate their religious beliefs, and threatens the welfare of thousands of beneficiaries of charitable services such as shelters and foster care agencies, by forcing a multitude of them to be shut down
- jeopardizes existing prohibitions on the use of federal taxpayer funds for abortion, likely pressuring or even mandating the performance of abortions by healthcare providers in violation of their consciences, and ultimately ending more human lives
