

Five ways the Biden-Harris Administration Is Impacting the Pro-Life Movement

Since President Biden took office in January, the Biden administration has cemented its status as the most pro-abortion administration in United States history. With pro-life policies being wiped off the books and strategic pro-abortion policies ready-and-waiting, this administration could cost hundreds of thousands of preborn children their lives in the coming years of the Biden presidency. Along with them, countless women will be left living in deep regret. Each pro-abortion effort of the Biden administration directly affects pro-life efforts to save lives.

Excluding the Hyde Amendment

Biden is the first president to exclude the Hyde Amendment — a pro-life rider preventing federal taxpayers from funding most abortions — from his proposed **budget**, aiming to force even pro-life federal taxpayers to pay for the abortions of low-income women, primarily through Medicaid. More distressing, however, is that without the Hyde Amendment in place, the number of preborn babies killed by abortion each year is likely to increase. The Hyde Amendment has **saved an estimated 2.4 million lives** from abortion — about 60,000 per year.

Undoing Trump's Protect Life Rule

One of Biden's first acts as president was to ask the Department of Health and Human Services to undo the Trump administration's Protect Life Rule, which prohibited Title X family planning funding from supporting abortion businesses. Any facility that committed abortions was ineligible under Trump's rule to receive the funding unless it physically and financially separated the abortion side of its business from its legitimate health care practices. Planned Parenthood refused to cooperate with the rule and walked away from \$60 million in Title X funding. The restoration of that funding allows Planned Parenthood to further promote abortion and increase its profits.

Promising to codify *Roe v. Wade*

Biden has vowed to codify *Roe v. Wade*, the 1973 Supreme Court decision that legalized abortion through all nine months of pregnancy, into law. Currently, states are able to pass restrictions on abortion after the preborn child is considered viable, which current standards place around 24 weeks. The law has yet to catch up, however, as babies as young as 21 weeks are capable of surviving outside the womb with proper medical care, and abortionists have admitted that 'viability' is a moving target and not a set standard in their view. If *Roe v. Wade* is codified in legislation, abortion on demand would become a "right" under federal law regardless of the reason or the child's age. Abortion would be completely unrestricted throughout the United States and states would be unable to pass any restrictions.

Expanding access to the abortion pill

In April, the Biden administration announced that it would temporarily lift an FDA safety rule known as REMS (Risk Evaluation and Mitigation Strategy) in place since 2000 that states the abortion pill must be dispensed by a certified prescriber and administered in a medical setting. These safety measures help ensure that a preborn child is no more than 10 weeks old (the age limit for the abortion pill), that the mother is not experiencing an ectopic pregnancy — in which case the abortion pill could cause her to hemorrhage and die — and that she has a doctor who is following her care. The abortion pill has been found to be four times more dangerous than the first-trimester surgical abortion procedure, yet the abortion industry saw an opportunity with the COVID-19 pandemic. With COVID as its excuse, the abortion industry began to advocate strongly for at-home 'DIY' abortions.

International funding of abortion

When Biden rescinded the Mexico City Policy during his first week in office, he ensured that federal taxpayer dollars would be used to fund abortions in other countries. According to Newsweek, 75% of Americans *oppose* funding international abortions with taxpayer dollars, including 61% of those surveyed who consider themselves "pro-choice." Likewise, a January 2021 Marist Poll found that 77% of Americans *oppose* using tax dollars to support overseas abortion, including 64% of those who consider themselves to be "pro-choice."

Fauci Funded Research With Body Parts From Viable, Healthy Babies Killed in Abortions

Anthony Fauci's agency is using American tax dollars to fund unethical experiments with body parts from potentially viable, healthy aborted babies. Fauci, Joe Biden's chief medical officer, also leads the National Institute of Allergy and Infectious Diseases.

A new investigation by the Daily Wire found that Fauci's agency supported a study at the University of California-San Francisco that used organs from 18 to 23 week aborted babies to study bacterial growth.

The study, "Viable bacterial colonization is highly limited in the human intestine in utero," was published in February 2020 in the journal "Nature Medicine."

According to the study, researchers used "donated" intestine, kidneys, spleens, and lymph nodes from aborted babies at 18 to 23 weeks gestation. The babies' organs came from the Department of Obstetrics, Gynecology, and Reproductive Science at Zuckerberg San Francisco General Hospital, the study noted.

The babies' organs "were collected by a single operator using sterile tools within 10 minutes of termination procedure and placed into sterile containers" and then "transported in media on ice and processed within 2 hours after collection," according to the study. The researchers acknowledged several sources of taxpayer funding that they used to conduct their study, including a National Institute of Allergy and Infectious Diseases grant from which the university used \$113,727 since 2017 (Grant No. F31 AI136336), the Daily Wire reports. Other taxpayer-funded grants came from the National Science Foundation and National Institutes of Health.

The group that initially discovered the study, Pro-Life San Francisco, has been urging UCSF to stop its unethical abortion and research practices, according to the report.

Earlier this week, Pro-Life San Francisco released documents it received from the university through a public documents request showing how UCSF is harvesting aborted babies' genitalia and other organs for research.

Unbeknownst to most Americans, their tax dollars are funding these disturbing, unethical abortion practices.

Earlier this summer, David Daleiden, founder of the Center for Medical Progress, told Townhall that Fauci's agency also gave \$61 million to the University of Pittsburgh in 2019 for scientific research, and some of that money funded grisly experiments involving aborted baby body parts being attached to mice and rats. In one study, scientists used scalps from aborted babies between 18 and 20 weeks of pregnancy to create "humanized" mice and rats to study the human immune system. The researchers described it as "full-thickness human skin." Along with their article, the researchers published photos of their experiment – horrific images that show tufts of babies' hair growing on the rodents.

Under the Obama administration, at least \$77 million tax dollars were spent on research projects that used aborted baby body parts, according to The Hill. The Trump administration cut off funding to the unethical research and created a new ethical advisory board to prevent further funding. However, the Biden administration quickly reversed the actions earlier this year.

Wisconsin Priest Fired from His Parish by His Catholic Bishop for taking a Pro-Life Stand

A Wisconsin priest who attracted national attention for telling Catholics to reject the Democratic Party because of its radical pro-abortion stance said he will challenge his bishop's request for his removal from his parish. Father James Altman, the priest at St. James the Less Church in La Crosse, told his parishioners that Bishop William Callahan accused him of being "divisive and ineffective" and recently asked him to resign. Within a few weeks the bishop changed that and the bishop removed him from his parish. This all started last year during the 2020 presidential election.

Ahead of the presidential election last year, Father Altman made some strong statements about Catholics' role in politics in America. In a video that drew national attention, the priest insisted that Catholics cannot vote Democrat because of the party's radical pro-abortion stance. He faulted "gutless cowards in the clergy" for failing to teach Catholics the truth about God and the value of every human life. "There will be 60 million and counting aborted babies standing at the gates of heaven barring

your Democrat entrance, and nothing you can say will ever excuse you for your direct or indirect support of that diabolical agenda here in the end," Altman said. The video had more than 1.2 million views on YouTube.

Last year, Altman said "Baloney!" to the people who accused him of being too political. He said politics fundamentally should be a moral enterprise, and Catholics have a "duty and obligation to speak up" when politicians act immorally.

In today's world the clergy that speaks out against abortion leaders seem to be the ones that get in trouble. The bishops in higher authority seem to want to protect the pro-abortion politicians and chastise the clergy that speak the truth. It could also be some of these bishops are more in tune with the Democrat party and their pro-abortion politicians than they are with the rights of the unborn. It is a sad day in our society when Father Altman appears to be out as a pastor in that diocese and nothing can be done to stop it.

The "silent majority" was mentioned by President Nixon in 1969, who labeled middle Americans who weren't protesting the Vietnam War or joining the counter culture — two activities being over-reported by the media of the day. The silent majority didn't speak up much but respected traditional American values with a good-natured approach to political issues. They were silent, but they voted. In 1972, Nixon was re-elected with one of the largest landslides in U.S. history — 520 electoral votes to only 17 for McGovern.

Today, most Americans focus on work and family and trust that our elected officials will work *for* us; and if they don't, the folks who pay attention to such stuff will vote them out. But after five years of hysteria over Donald Trump, the media have hyped so many radical liberal causes to the point where many conservative Americans feel they are an endangered minority. The Abortion Pill is Injuring Thousands of Women and the FDA Doesn't Require Any Reporting

Chemical abortions (via the abortion pill) are increasing rapidly in the United States. Among the states that have released chemical abortion data for 2019, chemical abortions jumped almost 12 percent from 2018. That trend is unlikely to slow, with the U.S. Food and Drug Administration (FDA) suspending an important element of its safety regulations on the abortion pill mifepristone to permit its distribution through the mail. Despite the dangers that mifepristone can pose to women, the drug is now widely available with almost no medical oversight.

Complications are significantly underreported

As chemical abortions in the U.S. increase, complications will likely increase as well, but abortion complication data in the United States is spotty. Since 2016, the FDA no longer requires distributors of mifepristone to report any adverse events other than death. Just over half the states collect information from abortion providers on complications resulting from abortion, and only a quarter of all the states require other healthcare providers to report abortion complications they treat. Of these, states enforce their reporting requirements to varying extents, and many complications are never reported.

However, what little information there is shows that chemical abortions lead to more complications than other abortion methods. A recent **analysis of adverse event reports** from the years that the FDA required wide-ranging reporting showed that chemical abortion has led to multiple known deaths and hundreds of hospitalizations, even though these adverse events were significantly underreported.

Higher rate of complications for those that are reported

Of the states that have reported complications resulting from different types of abortion procedures in recent years, most reported a higher rate of chemical than surgical complications.

In **Arkansas**, chemical abortions accounted for 89 percent of abortion complications, while chemical abortions made up just 55 percent of all abortions reported in the state. In **Pennsylvania**, chemical abortions composed 45 percent of the abortions but 60 percent of the complications. Chemical abortions in **Idaho** were 48 percent of abortions causing complications and 42 percent of total abortions. In **Missouri**, more reports of chemical abortion complications were received (53) than the total number of chemical abortions occurring in the state (15), suggesting that some women who obtained chemical abortions in other states suffered complications that were treated in Missouri. Only **Michigan** reported that chemical abortions made up a smaller share of complications (41 percent of 75 reported abortions with complications) than total abortions (52 percent).

Ohio is unique among the states with a special adverse event reporting system for chemical abortions. Any doctor who administers abortion drugs must report any complications that

occur to the Ohio State Medical Board. Ohio received 90 adverse event reports for chemical abortions performed in 2018, or 1.5 percent of all chemical abortions reported in the state that year.

Complication data from other states helps to fill in the picture. While **Texas** does not report the type of abortion procedure that results in each complication, its new complication reporting law has led to improved reporting in the state, with 229 complication reports submitted by healthcare facilities in 2019. Almost half (111 complications) were incomplete abortions – a common complication of chemical abortion.

Similarly, **Wisconsin** reported an enormous jump in “retained products” or incomplete abortions, with 621 cases in 2019, up from 73 the previous year. Separately, 35 of Wisconsin’s abortion reporting forms in 2019 indicated that the procedure was a surgical abortion following an incomplete or failed chemical abortion, an increase from the year before. Both Texas and Wisconsin have reported large increases in chemical abortions in recent years.

Large-scale studies reinforce state data showing increased risk of complications

While complication data is underreported for some states and completely missing for others, large-scale studies show the same pattern. An **analysis of Medicaid data** from California found that chemical abortions had a complication rate four times that of first-trimester surgical abortions. Even though visits back to the abortion center or to a different provider were not included, over five percent of the chemical abortions resulted in trips to the emergency room.

One of the **strongest studies** on chemical abortion complications examined data from Finland, where the complete medical history of each woman undergoing abortion is available. Similar to the California analysis, the Finnish study found that chemical abortions had four times the complication rate of surgical abortions, but recorded much higher complication rates overall. A full 20 percent of the more than 22,000 chemical abortions performed in Finland between 2000 and 2006 resulted in complications, with hemorrhage occurring in nearly 16 percent of chemical abortions and incomplete abortion in almost seven percent.

These high complication rates in a country with complete reporting indicate that abortion complications in the United States are probably significantly undercounted.

As mifepristone is transmitted via the mail, and proposals increase to provide it later in pregnancy and to women unsure of the length of their pregnancy, complications are likely to increase and reporting to get worse. Fortunately, some states have taken the initiative to implement their own safety protections and improve abortion complication reporting. As the FDA **slackens its oversight** of what has proven to be a dangerous drug, it will be up to the states to stand in the gap and ensure that safety standards are enforced.

Mom Refuses to Have Abortion to Finish College, Graduates Anyway

A young woman was terrified when she became pregnant. Lacking support from her boyfriend, she almost aborted her baby – but love triumphed. Brittany shares her story.

Brittany's pregnancy was unplanned. When she found out and told her boyfriend, informing him that she might abort their child, he was relieved and even encouraged the abortion. But Brittany began to have doubts about abortion, especially when she researched online testimonies of women who regretted killing their unborn babies.

"I Googled everything, so I decided to look up what occurs during an abortion, as well as the physical and emotional effects", Brittany recalls. "I knew that if I had an abortion, I would be haunted by it forever, like these women... Thankfully, I gave myself some time to think through all of the consequences before rushing to get one... "If I had an abortion, I knew I would spend every single day for the rest of my life thinking of all the 'what-ifs' and wondering what could've been." **"I saw true love for the first time."** Despite her unsupportive boyfriend, Brittany decided to keep the baby, with the love and support of her parents.

A scan at six weeks affirmed her decision: "I was only six weeks pregnant, but I remember seeing a flickering heartbeat on the screen... "Even though my baby wasn't formed yet, the organ that keeps us alive, the heart, was beating so strong. I saw true love for the first time on that ultrasound screen."

Several months later, Brittany gave birth to a beautiful boy, Noah, now aged 5.

"So worth it"

Brittany encourages other women who have unplanned pregnancies not to kill their children.

"Having a baby, raising a child, is hard, but so worth it. You will experience a love like no other. You will want to be better, do better, because you have a child looking up to you", she says. Brittany has now graduated from pharmacy school, with Noah attending the ceremony with her, and she will soon become a fully licensed pharmacist. Since her pregnancy, her ex-boyfriend and his family have not been in contact with her.

True love

Michael Robinson, SPUC Director of Communications, said: "Despite the natural trepidation that Brittany experienced, realizing that she was to become a mother, she rose to the challenge, refusing to victimize either herself or her baby boy. "The impact that abortion has on the health of women can be life-changing. Yet, growing evidence suggests that women are not being fully informed, and the consequences can be devastating.


"Thankfully, Brittany made the best decision for herself and Noah.

"But as SPUC's Daniel Frampton has also pointed out, men must take responsibility as well: 'meaning that a man should do his utmost to not place a woman in a position of even having to consider an abortion. And even should a pregnancy occur, that man can still embrace the mission of fatherhood.'
